## SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

Purpose: To survey and monument the boundary line agreement as approved by the City of Central Point, Oregon as File No 15013, dated May 6, 2015.

Procedure: The owners of these parcels of land entered into an agreement to establish their common boundary to the existing fence as shown hereon, on January 26, 2015, which was executed by both parties on February 15, 2015. It was decided that it would be prudent to have the City of Central Point also approve this agreed to boundary as a property line adjustment so there would be no zoning issues in the future. Following the City approval the line was monumented as shown hereon. It was not a part of the agreement to survey and monument the right of way that was acquired by the City in 2008 by deed, said right of way remains as is without monuments. The north boundary Tax Lot 200 was surveyed by Mark Boyden, S/N 11902, and the south boundary by this office, S/N 19835. The south boundary and west boundary of Tax Lot 300 was surveyed by L. J. Friar & Associates, PC, S/N 16590. The Friar survey also delineated the east boundary being Chicory Lane.
