SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

Purpose: This survey was conducted to monument the boundary of the tract of land as described in Instrument No 2012-020022 recorded in the Official Records of Jackson County, Oregon.

Procedure: A thorough review of the adjoining property deeds revealed that they are consistent with calls being the same bearings and distances and all call to the south boundary of the Happy Hollow Subdivision. There are no title conflicts. The south boundary of Happy Hollow Subdivision has been surveyed a number of time with varying results. The controlling monuments shown hereon were tied in a closed survey and analyzed against the record surveys. The original plat corners were held for the purpose of defining the south boundary of the subdivision. All of the surveys relied on the monument shown as being at the corner of Lots 14-15 however none of the surveyor's takes responsibility for setting the pipe. The title for this property commences at the southeast corner of Lot 12. This corner was prorated between the southwest corner of the subdivision and Lot 14-15 corner. The angle point of the south line of Happy Hollow was set on the extension of the line established from the southwest subdivision corner to Lots 14-15 at the record distance from said corner as shown. The lineal deed distance along said south boundary was used to establish the northeast corner of this survey and the remaining corners at right angles to the easterly leg of the said south boundary at record deed distances except for the west line all error being placed in the distance closing to said south boundary along the west line.
