PURPOSE: To survey and monument that property described as Parcel A of Instrument No. 00-12059 of the Official Records of Jackson County, Oregon

PROCEDURE: The west boundary of the property being surveyed has been previously surveyed and monumented per filed survey No. 4553. Monuments as found per that survey were located and held to control this survey. The east line of the property is described as the east line of the West half of the East half of Section 34. Said east line has been surveyed and monumented per BLM dependent resurvey and per filed survey No. 15155. Monuments as found per those surveys were held to control said east boundary. The north and south lines of the property were computed at deed record bearings and monuments were set as shown.
