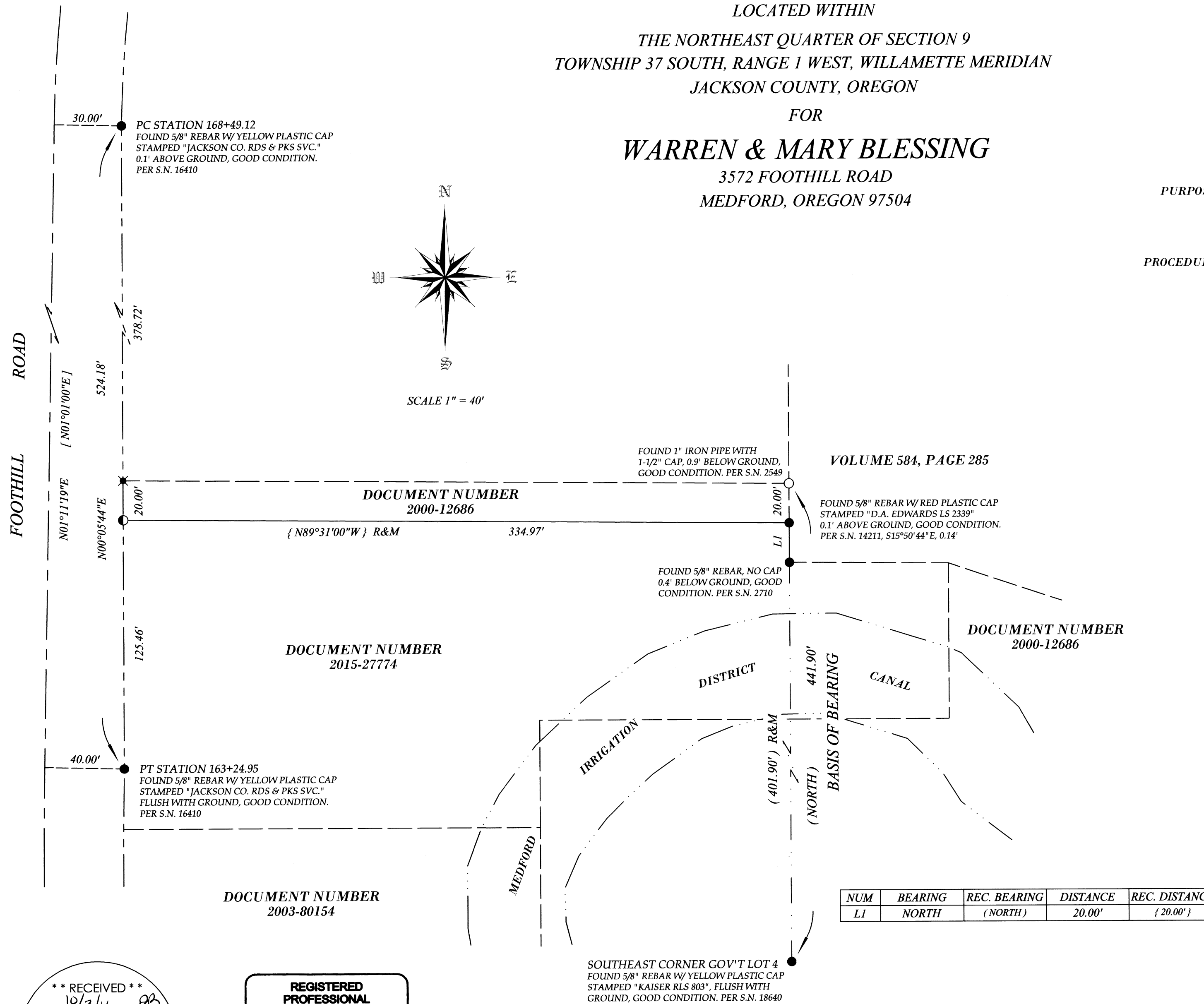
## SURVEY NARRATIVE

**PURPOSE:** TO SURVEY AND MONUMENT THE NORTH LINE OF A PIECE OF LAND RECORDED IN DOCUMENT NUMBER 2015-027774 OF THE OFFICIAL RECORDS OF JACKSON COUNTY, OREGON, PER THE REQUEST OF THE CLIENT.

**PROCEDURE:** THIS SURVEY WAS CONDUCTED USING A LEICA TCRP 1203+ ROBOTIC TOTAL STATION, DISTANCE PRISMS AND A LEICA CS15 DATA COLLECTOR. THE BASIS OF BEARING HELD IS THE EAST LINE OF GOVERNMENT LOT 4, SECTION 9, TOWNSHIP 37 SOUTH, RANGE 1 WEST OF THE WILLAMETTE MERIDIAN, JACKSON COUNTY, OREGON AS DETERMINED BY THE THREE FOUND MONUMENTS PER SURVEY NUMBERS 2549, 2710 AND 18640. THE RIGHT OF WAY OF FOOTHILL ROAD WAS DETERMINED BY THE TWO FOUND MONUMENTS PER SURVEY NUMBER 16410. THE NORTH LINE WAS THEN CALCULATED PER DEED RECORD.
