SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

PURPOSE: TO SURVEY AND MONUMENT THE EASTERLY AND WESTERLY BOUNDARIES OF THAT TRACT OF LAND DESCRIBED IN INST. NO 2013-023741, OFFICIAL RECORDS OF JACKSON COUNTY, OREGON.

PROCEDURE: UTILIZING DATA FROM S/N 2537, S/N 22070, AND INST NO. 2013- 023741, AND A FIELD SURVEY THE MONUMENTS OF RECORD WERE TIED AS SHOWN. THE NORTHERLY BOUNDARY WAS ESTABLISHED AT DEED DISTANCE ALONG THE BOUNDARY BETWEEN FOUND MONUMENTS FROM S/N 2537. THESE FOUND MONUMENTS ARE ON THE LINE COMMON WITH SCHOOL DISTRICT NO 9 ARE DEED CORNERS AS DEFINED IN INST NO 2006-19789 AND CALLED FOR IN INST NO 2013-023741. THESE CORNERS ARE HELD BY THIS SURVEY WITH THE BOUNDARY'S OF THE PROPERTY COMPUTED PER DEED RECORD AND ROTATED TO MATCH OUR BASIS OF BEARING ABOUT THE EASTERLY DEED CORNER. SUBSEQUENT TO OUR BOUNDARY RESOLUTION BARY KAISER SURVEYED THE PROPERTY TO THE NORTH SHOWN HERE ON, THESE MONUMENTS ARE ACCEPTED. RECORD TIES TO THE DLC CORNER PER S/N 2537 WITH A MEASURED TIE TO THE WITNESS MONUMENT FOR THE DLC CORNER SHOWN HEREON.
