## SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250, OREGON REVISED STATUTES

**PURPOSE:** Pursuant to Client's request and direction, perform a boundary survey, recover existing monuments, perform a boundary resolution, establish monuments at corners as needed, process a Property Line Adjustment through the City of Medford (File Number: PLA-15-171), draft the resultant tracts and file a Map of Survey in the office of the Jackson County Surveyor.

**PROCEDURE:** Utilizing Trimble 5700 GPS equipment, Trimble S6 & S7 Robotic Total Stations and Trimble TSC3 Data Collectors with Trimble Access software, all found monuments were tied within closed loop traverses or via redundant ties.


Records utilized for this survey: Instruments Numbered 2016-017308 and 2016-040835, of the Official Records of Jackson County, Oregon; Surveys Numbered 1736, 5266, 8937, 10266, 11121 and 14947, all as filed in the office of the Jackson County Surveyor; and HOCKENYOS ADDITION, filed for Record on March 21, 1929 in Volume 5 of Plats at Page 49, of the Records of Jackson County, Oregon.

Held found references per Survey Number 14947 at the intersection of East McAndrews Road and Court Street, from which held the record bearing per Survey Number III2I for Court Street to establish the centerline thereof. East McAndrews Road was established by holding the found monument at the intersection of East McAndrews Road and Central Avenue and the record bearing per Survey Number III2I for East McAndrews Road to compute the centerline thereof. Similarly, Central Avenue was established by holding said centerline monument and the record bearing per said survey to compute the centerline thereof. From which, offset the computed centerlines by the record distances to compute the subsequent right-of-ways.

The southwesterly boundary of Hockenyos Addition was resolved utilizing the following method: held the record distance of 139.70 feet per Survey Number 10266, from the found monument originally set per Survey Number 8937 to establish the most southerly corner of Hockenyos Addition. The most westerly corner of Hockenyos Addition was established by holding the record distance of 537.67 feet per Survey Number 11121 from the found 0.38 caliber shell set per last said survey. From which, computed the southwesterly boundary by holding a line between the southerly and westerly corners described hereinabove.

The interior lots of Hockenyos Addition were computed utilizing found monuments and record bearings and distances per the Plat. From which, established the adjusted resultant tracts as depicted on the accompanying map, pursuant to the approved City of Medford File Number PLA-15-171 and the subsequent Instrument Number 2016-040835, said records.

Monuments were established as depicted hereon, on December 29, 2016.
