



Written narrative to accompany plat for Hacienda Park Extension NO. 2 Located in the City of Phoenix, Jackson County, Oregon.

Surveyed for Edward Stevens, 3672 S. Pacific Highway, Medford, Oregon. Survey made in February and March 1963

Proceedure: Having all the original lot pins in place on three sides of this tract we expected to immediately go ahead and complete the staking in a routine manner. But either due to minor irregularities in the original work, or due to the fact that all pins on the tract had been damaged by placing 2" x 4" stakes immediately against them it was not possible to precisely arrive at the original angular bearings even after a great amount of effort and time.

However be it noted that the bearing of N 35°03'30"W shown on Sharin Drive from the initial point to the beginning of the curve at the northerly end of the tier of lots, is also the bearing of the centerline of the street from the intersection of Oak Street and Sharon Drive to the center of the street at the above mentioned curve.
