

### **LOCATION**:

Located in the Northeast One-quarter and Southeast One-quarter of Section 27, Township 37 South, Range 1 West of the Willamette Meridian, in the City of Medford, Jackson County, Oregon.

#### **PURPOSE OF SURVEY:**

Pursuant to Client's request and direction, perform a boundary survey, recover existing monuments, perform a boundary resolution, establish monuments at corners as needed, and file a Map of Survey in the office of the Jackson County Surveyor.

#### **SURVEY REFERENCES/PROCEDURES:**

Records utilized: Instruments Numbered 2002-059740, 2004-041949, 2007-019933, 2017-003447, 2016-012168, 2017-006949, and 2017-006950, all of the Official Records of Jackson County, Oregon; FAIR OAKS ORCHARD TRACTS, recorded September 15, 1910 in Volume 2 of Plats at Page 50 of the Records of Jackson County, Oregon; SUMMERFIELD AT SOUTH EAST PARK, PHASE 11A, recorded September 26, 2013 in Volume 39 of Plats at Page 10, of the Records of Jackson County, Oregon (also filed as Survey Number 21337 in the office of the Jackson County Surveyor); SUMMERFIELD AT SOUTH EAST PARK, PHASE 10, recorded April 22, 2016 in Volume 42 of Plats at Page 14, of the Records of Jackson County, Oregon (also filed as Survey Number 21961 in the office of the Jackson County Surveyor); SUMMERFIELD AT SOUTH EAST PARK, PHASE 15, recorded May 4, 2016 in Volume 42 of Plats at Page 15 of the Records of Jackson County, Oregon (also filed as Survey Number 21969 in the office of the Jackson County Surveyor); Surveyor); Surveys Numbered 7254, 20042 and 21390, all as filed in the office of the Jackson County Surveyor.

Equipment/Software utilized: Trimble R10 GNSS System, Trimble TSC3 data collectors with Trimble Access Software; Trimble S7 Robotic Instruments, Trimble Business Center and Trimble Terramodel.

The basis of bearing for this survey is the centerline of Calle Vista Drive per Summerfield At South East Park, Phases 1 and 5, filed as Surveys Numbered 17588 and 19538, respectively, in the office of the Jackson County Surveyor.

Utilized established control, tied and set monuments, and boundary resolutions as previously performed on said Surveys Numbered 21337, 21390, 21961 and 21969 to define and resolve the location of the "Reserve Acreage Future Development" per Summerfield At South East Park, Phase 15. From which, utilized said Instrument Number 2017-003447 to locate the exterior boundary of the donated area and Instrument Number 2017-006949 to establish the dedicated right-of-ways for Lone Oak Drive and Michael Park Drive, thereby defining the subject tract of land.
