SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

PURPOSE: TO SURVEY AND MONUMENT THE PROPERTY LINE ADJUSTMENT AS APPROVED BY JACKSON COUNTY DEVELOPMENT SERVICES IN FILE NUMBER 439-16-00004-SUB, DATED 02/24/2016.

PROCEDURE: A FIELD SURVEY WAS CONDUCTED AND FOUND MONUMENTS OF RECORD WERE TIED. SURVEY DATA FROM S/N 1085, S/N 20533, AND INSTRUMENT NUMBERS 72-00700, 74-00415, 04-00050, 04-072002, 09-034590, VOL. 10 PG. 790 (CASINO RD), VOL. 321 PG. 347 (COGHILL LANE) AND VOL. 348 PG. 337, WERE UTILIZED. THE REVIEW OF ALL DEEDS SHOW A CLEAR INTENT THAT THE DESCRIPTIONS FOR THE SUBJECT TRACTS AND ADJOINING TRACTS HAVING THE SAME BEARINGS AND DISTANCES FROM THE DLC. THE PREVIOUS DEEDS ARE MIXED WITH RECORD AND SURVEYED DATA, SLIGHTLY DIFFERENT FROM RECORD. THE SOUTH LINE OF THE TRACT DESCRIBED IN VOL. 348 PG. 337 WAS ESTABLISHED BY HOLDING FOUND MONUMENTS SET ON S/N 20533, THE NORTH LINE OF THE TRACT WAS HELD PARALLEL TO THE SOUTH LINE, AT RECORD DISTANCES FROM THE NORTHEAST CORNER OF DLC 78. THE EAST AND WEST LINES OF THE TRACTS WERE HELD PARALLEL TO THE EAST LINE OF DLC 78, PER DEED RECORDS. THE SOUTH LINE OF THE TRACTS DESCRIBED IN INST. NO. 72-00700 AND 74-00415 WAS HELD TO THE ROTATED DEED RECORD BEARING AND DISTANCE.
