

## MAP OF SURVEY FOR ALTA ROBINSON ESTATE

SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250 OREGON REVISED STATUTES

PURPOSE: To survey and monument that property described in Volume 256, Page 107 of the Deed Records of Jackson County, Oregon.

PROCEDURE: the west line of the property was previously surveyed and monumented in 1966 per Survey No. 3139. That line was again part of a survey done in 1983 by Ed McGinty per Survey No. 9711. McGinty held the monuments from the 1966 survey to control his east boundary. For purposes of this survey, I held the 1966 survey to control the location of my west boundary. According to the deed record, the east boundary is the west line of a 33 foot strip of land that is excepted out of the deed description. The east line of this 33 foot strip has been surveyed and monumented by Barry Kaiser per survey No. 21086. I held monuments as found per that survey to control the location of the 33 foot strip of land. Monuments as found per surveys No. 17724, 18736 and 21086 were held to control the north right-of-way line of Ross Lane. A search was made for the Southeast corner of Donation Land Claim (D.L.C.) No. 66. The brass disc monument was located 0.1 feet deep, with abrasions on the disc and the monument was loose, possibly disturbed by farm activity. With this monument now being questionable, We extended our survey to the west to the Northwest Corner of D.L.C. 69, which has been paved over. A 5/8 pin set by Roger Roberts, per survey No. 10087 was found and held to compute the location of the disturbed D.L.C. No. 66 corner, which computed location is in close agreement with dimensions as shown on survey No. 21086.
