## SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

PURPOSE: OUR CLIENT REQUESTED US TO SURVEY AND MONUMENT THE COMMON BOUNDARY BETWEEN THOSE TRACTS OF LAND DESCRIBED IN INSTRUMENT NUMBERS 1998-46819, (PARCEL I, TRACT I), AND 2017-001292, OF THE OFFICIAL RECORDS OF JACKSON COUNTY, OREGON.

PROCEDURE: A FIELD SURVEY WAS CONDUCTED AND MONUMENTS OF RECORD WERE TIED AS SHOWN. THE DEEDS OF RECORD CALL FOR CARDINAL DIRECTIONS OF NORTH SOUTH EAST AND WEST ORIGINATING AT THE 1/4 CORNER, WITHOUT ANY CALL TO ALIQUOT LINES. THE DEEDS WERE WRITTEN AT THE TIME OF THE LAND DIVISION DONE IN 1979, AS APPROVED BY JACKSON COUNTY, AUTHORIZING CREATION BY MAJOR LAND PARTITION.
THIS WAS PRIOR TO THE PLATS OF TODAY SO DEEDS ARE REQUIRED TO
ACTUALLY CREATE PARCELS OF LAND AT THE TIME WITHOUT THE BENEFIT OF A FULL BOUNDARY SURVEY. AT THIS TIME THE EAST WEST CENTERLINE OF SECTION 19 HAD NOT BEEN SURVEYED. IN 1989 THE BLM SURVEYED THE EAST WEST CENTERLINE OF SECTION 19. THIS SURVEY IS BY THE DEED CALL WITH A PORTION OF THE TITLE BEING NORTH OF THE SURVEYED EAST WEST CENTER LINE OF THE SECTION. THE DEED CREATES THE BOUNDARY NOT THE SURVEY IN THIS CASE. MONUMENTS WERE SET ACCORDING TO THE DEED CALLS FROM INST. NO. 2017-001292 AS SHOWN HEREON. IN 1979 NORTH OF SAID EAST WEST CENTERLINE WAS UNDER DIFFERENT OWNERSHIP THEREFORE THE CURRENT OWNERS HAVE NO RIGHT TO THE AREA NORTH OF THE EAST WEST CENTER LINE IN THE DEED
