

LOCATION:

Located in Donation Land Claim Numbers 48 and 49, in the Southwest and Southeast Quarters of Section 32, Township 38 South, Range 1 East of the Willamette Meridian, Jackson County, Oregon.

PURPOSE:

To survey and monument Parcels 1 though 4 as described in Instrument Number 2010-021712 of the Official Records of Jackson County, Oregon.

BASIS OF BEARINGS:

Basis of Bearing is between found Jackson County re-establishment brass caps monumenting the Southeast corner of Donation Land Claim Number 48 and the Northwest corner of Donation Land Claim Number 49 per filed survey number 6319 at the Jackson County Surveyor's Office, Oregon.

Said bearing being: North 0°08'14" West.

PROCEDURE:

Utilizing a Topcon total station, a Trimble S6 robotic total station and electronic data collectors and reflector prisms, I tie and set the monuments as shown on the accompanying plat. The found monuments per survey number 4518 were held and the line projected to intersect the boundary line agreement as described in Instrument Number 82-01761. This boundary line agreement was calculated from the deed and rotated to the found monuments being the northwest corner of DLC 51 and the found iron bolt called in Instrument Number 82-01761, resulting in a good fit with the existing creek center line. Monuments for Jackson Road per survey numbers 4517 and 12314 were held as shown and the intervening courses calculated to fit as shown. The found 5/8 inch iron pin at the northeast corner of Parcel 1 per Partition Plat P-6-1991 was found disturbed and bent 90° at its mid point. The bottom appeared to be perpendicular. This position was held for line and record distance was projected through it from the southeast corner of said Parcel. This calculated position was monumented by this survey and the disturbed pin removed. A distance-distance intersection of record distances from the newly monumented northeast corner and the found southwest corner was used to establish the northwest corner of said Parcel 1. The north - south lines for Parcels 1 and 2 per Instrument Number 2010-021712 were held parallel with the donation Land Claim line used for the Basis of Bearing.
