

SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250 OREGON REVISED STATUTES

Location:

Lot 8 of Block 1 of LEWIS ADDITION in the Northeast one-quarter (1/4) of Section 25, Township 37 South, Range 2 West, Willamette Meridian, in

the City of Medford, Jackson County, Oregon.

Purpose:

To survey, monument and record a Map of Survey of the property described in Document No. 2015-024539, Official Records of Jackson County, Oregon.

Procedure:

I used reference points from the City of Medford field books to establish the center lines of North Orange Street and Fourth Street, North Orange Street and West Main Street and North Peach Street and Fourth Street. I used record distance along Fourth Street from Survey No. 3287 to compute its intersection with North Peach Street. From this computed intersection, I created a line Southerly to a ¾" iron pin at West Main Street referenced on Survey No. 3287. This positioning fit exceptionally well with two found 5/8" iron pins from Survey No. 7898. I established the center line of West Main Street to be the same bearing as the center line of Fourth Street as previous Surveys have done.

From these established center lines, I proceeded to recreate Block 1 of LEWIS ADDITION and Block 2 of BUNGALO ADDITION. These Subdivisions were recorded in May of 1908 (BUNGALO) and September of 1908 (LEWIS). It's obvious from the Plats that the Easterly line of LEWIS and the Westerly line of BUNGALO were intended to be coincident. The computed distances along the North line checked closely with Plat record. The computed distances along the South line created an excess of over 2.5 feet. Holding the found 2" iron pipe at the Northeast corner of Lot 13 of BUNGALO, I established the Northerly line of the 19-foot alley as a parallel bearing to the center line of West Main Street. I then proportioned the lots in a Northerly direction. As the BUNGALO Plat was created first and simulating previous Surveys done by Ed McGinty and Mark Boyden, I gave LEWIS ADDITION record East-West distances with the excess going to BUNGALO ADDITION.

Additionally, Volume 510, Page 403 of the Deed Records, Ordinance No. 8060, vacated "the Westerly 1 foot of the North and South alley, along the easterly line of Block 1, Lewis Addition ...". The East-West dimension of 179.00 feet reflects this vacation.
