SURVEY NARRATIVE

PURPOSE:

To monument the four corners of that 135 ft. x 360 ft. tract described in Deed Document No. 97-12633 of the Official Records of Jackson County. This does not include the northern most 30 feet, being public right of way for the south

30 feet of Wilson Road.

PROCEDURE: The location of the southeast corner of Section 35 was determined by a distance/distance intersection using 2636.16 ft. (record distance from CS

12965) southerly from the brass cap monument at the east 1/4 corner of Section 35, and record distance of 223.03 ft. (County Surveyor) easterly from the Witness Corner brass cap. No monument was found or set for this calculated section corner location. The record bearing of N 00°05'16" W (CS 12965) was then applied to this line, and divided by 4 to determine the location for the N-S 1/64th corner.

The west boundary of the NE 1/4 of the NE 1/4 of the SE 1/4 of Section 35 was determined by running a line from the monument found at the southwest corner northerly, through the found monument, a record distance (CS 12965) of 659.46 ft. This calculated point was held for the centerline of Wilson Road running S 89°50'22" E to the brass cap at the 1/4 corner.

The location of the tract to be monumented was then determined as shown on the map.

It should be reported here that the 2.5 inch diameter Witness Corner brass cap and the 1 inch diameter reference brass cap are located in the concrete gutters running north-south on each side of Iven Street, rather than at the east end and west end of rolled curbing, as stated in the 1998 County Surveyor Third Re-establishment record. The Witness Corner is located in the concrete gutter in front of 1348 Iven Street.
