SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

PURPOSE: TO SURVEY AND MARK THE NORTHERLY LINE OF LOT 4, SECTION 22 TOWNSHIP 32 SOUTH, RANGE 2 EAST, WILLAMETTE MERIDIAN, IN JACKSON COUNTY, OREGON, ALSO DESCRIBED IN INST. NO. 2013-24797, OF THE OFFICIAL RECORDS OF JACKSON COUNTY, OREGON. PROJECT NAME: BUTTON RIDGE.

PROCEDURE: A FIELD SURVEY WAS CONDUCTED AND MONUMENTS OF RECORD WERE RECOVERED AND TIED AS SHOWN. DURING THE FIELD SURVEY A 2 1/2 INCH METAL EXPANDER WAS RECOVERED AT THE SOUTH 1/16 CORNER THAT THIS OFFICE HAS NOT BEEN ABLE TO FIND RECORD OF, (BEARING TAGS INDICATE ELK LUMBER COMPANY). RECORDED SURVEYS 9499 AND 9581, (U.S. FOREST SERVICE DEPENDANT RESURVEYS), SHOW TIES TO THE MONUMENTS RECOVERED AT THE WEST 1/4 CORNER OF SECTION 22, SOUTHWEST SECTION CORNER. S/N 9499 ESTABLISHED THE SOUTHWEST 1/16 CORNER, BUT DO NOT REFERENCE THE MONUMENT AT THE SOUTH 1/16 CORNER, THE DISTANCES TO THE UNRECORDED MONUMENT MATCH THE FOREST SERVICE SURVEYS ALONG WITH FOREST SERVICE SIGNAGE AT THE MONUMENT WOULD INDICATE THAT THE MONUMENT WAS HELD. THEREFORE THIS OFFICE HELD THE UNRECORDED MONUMENT. THE NORTH LINE OF GOVERNMENT LOT 4 WAS THEN BLAZED AND MARKED TO HANCOCK FOREST MANAGEMENT STANDARDS.
