## SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

PURPOSE: TO SURVEY AND MONUMENT THAT PARCEL OF LAND DESCRIBED IN INSTRUMENT NUMBER 2017-022317, OF THE OFFICIAL RECORDS OF JACKSON COUNTY, OREGON.

PROCEDURE: UTILIZING CONTROL ESTABLISHED DURING S/N 19966 ON FILE AT THE JACKSON COUNTY SURVEYOR'S OFFICE, THE BOUNDARY OF THE SUBJECT PARCEL WAS ESTABLISHED PER DEED AT RECORD ANGLES. SHAFER LANE IS LOCATED AT DEED RECORD DISTANCE NORTH OF THE SOUTHEAST CORNER OF DONATION LAND CLAIM 38. THE LOCATION OF SHAFER LANE WAS COMPARED TO THE RESULTS OF S/N 10890, 16922, 18160 AND 19953 WITH FAVORABLE RESULTS. THE RECORD ANGLES ARE AT OR NEAR 90° BEING 90°00'09" S/N 18160, 89°59'58" S/N 19966 AND 90° S/N 19953, 16822 AND 10890 APPLIED TO THE CENTERLINE AS MONUMENTED AND IN CONFORMANCE TO THE DEED RECORD.
