

PURPOSE: TO SURVEY AND MONUMENT THE TRACT DESCRIBED IN DEED RECORD 1977-15437, JACKSON COUNTY RECORDS

PROCEDURE: UTILIZING RECORD MAPS AND DEED INFORMATION NOTED ON THE MAP, A FIELD SURVEY WAS MADE UTILIZING A CARLSON BRX5 GNSS RECEIVER, AND CARLSON SURVEYOR 2 DATA COLLECTOR CONNECTED TO THE OREGON REAL TIME GEODETIC NETWORK (ORGN). REDUNDANT MEASUREMENTS WERE MADE TO FOUND AND SET MONUMENTS AND THEIR POSITIONS ARE REPORTED AS SHOWN HEREON. BOUNDARY DETERMINATIONS WERE MADE AS FOLLOWS.

NORTH LINE: THE NORTH LINE OF THE SUBJECT PROPERTY WAS DETERMINED BY TYING MULTIPLE MONUMENTS ALONG THE EASEMENT FOR ROADWAY INGRESS AND EGRESS AND PUBLIC UTILITIES DESCRIBED IN V.560 P.322 OF JACKSON COUNTY

SOUTH LINE: THE SOUTH LINE WAS DETERMINED BY OFFSETTING THE NORTH LINE THE RECORD DEED DISTANCE OF 191 FEET AS SHOWN IN INSTRUMENT NUMBER 1977-15437 JACKSON COUNTY OFFICIAL RECORDS.

WEST LINE: THE WEST LINE WAS DETERMINED BY HOLDING THE FOUND NORTHWEST CORNER OF THE PROPERTY AND TURNING THE RECORD ANGLE OFF THE RIGHT OF WAY. THIS WAS SUPPORTED BY A FOUND PIN SET ON MAP OF SURVEY NO. 4479

THE EAST LINE WAS DETERMINED BY HOLDING THE RECORD DISTANCE FROM THE FOUND NORTHWEST CORNER ALONG THE RIGHT OF WAY TO THE NORTHEAST CORNER OF THE PROPERTY, AND THEN TURNING THE RECORD ANGLE OFF THE RIGHT OF WAY. THIS WAS SUPPORTED BY A FOUND PIN SET ON MAP OF SURVEY NO. 12237
