## SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

TO SURVEY AND MONUMENT A PROPERTY LINE ADJUSTMENT BETWEEN TWO TRACTS OF LAND DESCRIBED WITHIN INSTRUMENT NO. 2011-027756 OF THE OFFICIAL RECORDS IN JACKSON COUNTY, OREGON.

PROCEDURE:

UTILIZING AN ELECTRONIC LEICA 1203 ROBOTIC TOTAL STATION AND RANGING PRISMS, IN CONJUNCTION WITH A LEICA 1200 SMART ROVER GNSS RECEIVER, I SURVEY THE PROPERTY LINE ADJUSTMENT AS SHOWN HEREON. THE HISTORIC DESCRIPTIONS OF MOST DEEDS IN THIS AREA, INCLUDING THE THE SUBJECT TRACTS, COMMENCE AT THE SOUTHEAST CORNER OF SECTION 16 THENCE RUN NORTH AND WEST TO A POINT INTERSECTING THE NORTH LINE OF BERGLUNDS ADDITION AT THE WEST LINE OF PINE STREET, A COUNTY ROAD. THERE HAS BEEN MANY DISCREPANCIES FOUND OVER THE YEARS IN THE DEED AND SURVEY RECORDS FOR SOME OF THE STREET RIGHT-OF WAY WIDTHS AND LOCATION, OF WHICH WERE NOTED ON SURVEY NO. 10871 BY JACKSON COUNTY SURVEYOR, ED McGINTY IN 1987 WHICH RE-MONUMENTED THE CENTERLINE OF PINE STREET ALONG THE EAST LINE OF SAID SECTION 16. THIS SURVEY RETRACED MANY OF THESE CENTERLINE MONUMENTS WHICH FIT EXTREMELY WELL WITH McGINTY'S SURVEY RECORD WHICH I HOLD FOR PINE STREET. FOLLOWING McGINTY'S SURVEY, MALCOLM CLARK COMES IN WITH SURVEY NO. 11053 & 11171 AND MONUMENTS PROPERTIES BETWEEN FOURTH STREET AND THE SOUTH LINE OF THE SUBJECT TRACTS FOR THIS PROPERTY LINE ADJUSTMENT. MONUMENTS ESTABLISHED BY CLARK'S SURVEY WERE RECOVERED AT THE SOUTHEAST AND SOUTHWEST CORNERS FOR THIS SURVEY AND FIT REASONABLY WELL WITH THE SURVEY AND DEED RECORDS. THE NORTH-SOUTH LINES OF THE SUBJECT TRACTS MATCHED WELL BETWEEN CLARK'S SURVEY AND MONUMENTS RECOVERED FROM SURVEY NO. 5272 BY MARK BOYDEN IN 1978. I HOLD DEED RECORD DISTANCES FOR THE EAST-WEST LINES WHICH ALSO FIT WELL WITH CLARKS SURVEY RECORD AND THE ADJOINERS TO THE WEST. ONE ODDITY THAT CAME UP THAT DOESN'T AFFECT THIS SURVEY WAS VARYING RIGHT-OF-WAY WIDTHS FOR FOURTH STREET DEPENDING ON VARIOUS LOCAL SURVEYS. IT WAS NOT THE PURPOSE OF THIS SURVEY TO RESOLVE THE ISSUE SINCE IT HAS NO RELATION TO THIS SURVEY.
