## NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO MARK THE PROPERTY LINES COMMON TO THOSE TRACTS OF LAND DESCRIBED IN DOCUMENT NOS. 02—12228 AND 03—12756, OFFICIAL RECORDS OF JACKSON COUNTY, OREGON IN A MANNER SUITABLE FOR FENCE CONSTRUCTION, AND TO "AS—BUILT" THE LOCATION OF A NEW FOUR TO SIX FOOT HIGH CEDAR FENCE LOCATED IN THE VICINITY OF SAID COMMON LINES.

A REVIEW OF RECORD DEED DOCUMENTS AND SURVEYS PRIOR TO THE COMMENCEMENT OF FIELD WORK SHOW THE LEGAL DESCRIPTIONS OF THE SUBJECT PROPERTIES IDENTICAL WITH COURSES SHOWN ON JACKSON COUNTY FILED SURVEY NOS. 2870 AND 3769. BOTH FILED SURVEYS WERE BY SIDNEY SYMTHE, OREGON LAND SURVEYOR NO. 525, AND BOTH SURVEYS SHOW "THE SEGREGATION OF A LAND PARCEL" FROM A LARGER TRACT, WITH SAID SURVEY NO. 3769 CREATING WHAT IS NOW THE CARDOZA PARCEL IN ITS CURRENT CONFIGURATION. IN ADDITION, SURVEYOR SYMTHE INCLUDED A "METES AND BOUNDS" LEGAL DESCRIPTION OF SAID PARCEL ON SAID FILED SURVEY. THAT LEGAL DESCRIPTION IS HARMONIOUS WITH THE CARDOZA DEED, DOCUMENT NO. 03–12756, OFFICIAL RECORDS OF JACKSON COUNTY, OREGON. THE LEGAL DESCRIPTION ON THE CARDOZA DEED, AND APPARENTLY ALL SENIOR DEEDS DESCRIBING THAT SAME PROPERTY, DOES NOT CLOSE MATHEMATICALLY BY A FOOT. BY CHANGING THE COURSE "N86°27'30"W 184.68 FEET, TO N86°27'30"W 183.68 FEET, THE DESCRIPTION CLOSES WITHIN 0.06 FT. THE CROOKSTON LEGAL DESCRIPTION CONTAINS TWO "MORE OR LESS" QUALIFIERS AND THEREFOR CANNOT BE CHECKED FOR MATHEMATICAL CLOSURE. AT ANY RATE, THE TWO COURSES ALONG THE LINES COMMON TO THE SUBJECT PROPERTIES ARE IDENTICAL.

ON JULY 21, 2017, I RECOVER ALL MONUMENTS SHOWN AS FOUND ON THE DRAWING AND TIE THEM INTO A CONTROL TRAVERSE. A SEARCH FOR THE MONUMENTS BOTH ALONG THE CENTERLINE OF THE EAST (LEFT) FORK OF FOOTS CREEK ROAD, AND THE NORTHEAST CORNER OF THE CROOKSTON PROPERTY, AS SHOWN ON FILED SURVEY NO. 3769, PROVED UNSUCCESSFUL. I LOCATED THE EXISTING WIRE FENCE ALONG THE MOST SOUTHERLY OF THE TWO COMMON LINES, LOCATED THE EDGES OF THE CHIP SEALED FOOTS CREEK ROAD TO DETERMINE THE CENTERLINE OF SAME, AND THEN STAKED BOTH COMMON LINES WITH HUBS AND LATH IN A MANNER CONSISTENT WITH FENCE CONSTRUCTION, AS SHOWN ON THE DRAWING. THE NORTHERLY OF THE TWO COMMON LINES HAS AN ORIGINAL MONUMENT AT BOTH ENDS OF SAID LINE. IN ABSENCE OF ANY EVIDENCE TO THE CONTRARY, I HELD THE RECORD BEARING TO ESTABLISH THE SOUTHERLY OF THE TWO COMMON LINES.

ON MAY 7, 2018, I RETURN TO THE PROPERTIES AND LOCATED THE NEW CEDAR FENCE AS SHOWN ON DETAIL "A" OF THE DRAWING. I ALSO FOUND AND LOCATED THREE "T"—BAR POSTS, SET BY PERSONS UNKNOWN, CLOSE TO AN ALIGNMENT BETWEEN TWO OF MY RANDOM "TRAVERSE CONTROL POINTS", AGAIN AS SHOWN ON SAID DETAIL "A". I ALSO COMPUTE A POSITION USING MY PREVIOUSLY CALCULATED CENTERLINE OF FOOTS CREEK ROAD AND SET A "WITNESS CORNER" MONUMENT 30 FEET NORTHEASTERLY FROM SAID CENTERLINE ALONG THE RECORD PROPERTY LINE BEARING.

REMAINING COURSES AROUND BOTH SUBJECT PROPERTIES WERE CALCULATED AND ARE SHOWN HEREON FOR INFORMATIONAL PURPOSES. A TRIANGULAR DEED GAP BETWEEN PARCELS 1 AND 2 OF DOCUMENT NO. 02-12228, OFFICIAL RECORDS OF JACKSON COUNTY, OREGON IS SHOWN ON DETAIL "B" OF THIS DRAWING.
