
PROPERTY LINE ADJUSTMENT MAP OF SURVEY



Located in the North-west One-quarter of Section 15, Township 35 South, Range 4 West of the Willamette Meridian, in the City of Rogue River, Jackson County, Oregon.

PURPOSE OF SURVEY:

Pursuant to Client's request and direction, perform a boundary survey, recover existing monuments, perform a boundary resolution, establish monuments at corners as needed, process a Property Line Adjustment through Jackson County (File Number: 439-17-00076-SUB), draft the resultant tracts and file a Map of Survey in the office of the Jackson County Surveyor.

SURVEY REFERENCES/PROCEDURES:

Records utilized: Instrument Numbered 2017-033549, 2017-033551, 2018-015530, of the Official Records of Jackson County, Oregon; QUEEN'S BRANCH SUBDIVISION, filed for record on November 22, 1978 in Volume 13, Page 63 of the Plat Records of Jackson County, Oregon (and filed as Survey Number 7492 in the office of the Jackson County Surveyor); Surveys Numbered 920 and 2841, as filed in the office of the Jackson County Surveyor. Equipment/software utilized: Trimble R10 GNSS equipment, Trimble TSC3 data collector with Trimble Access software; Trimble S7 Robotic Instrument, Trimble Business Center and Trimble Terramodel software.

Linear unit (horizontal): International Foot (ift). Linear unit (vertical): U.S. Survey Foot (usft).

Vertical datum: North American Datum of 1988 (NAVD88)

All bearings and distances shown on the accompanying map are projected (grid) values based on the projection definition herein and above. This projection was utilized in order to minimize the difference between projected (grid) distances and horizontal (ground) distances at the topographic surface within the design area of this coordinate system.

The basis of bearings is Geodetic North. Note that the grid bearings depicted do not equal geodetic bearings due to meridian convergence.

Orthometric heights (elevations) are referenced to the NAVD88 datum and were attained via solution sets obtained from the NGS OPUS website for static GPS occupations utilizing said Trimble R10,

This survey was conducted utilizing the Global Navigation Satellite System (GNSS) referenced to the National Spatial Reference System (NSRS). NSRS coordinate values were derived from solution sets obtained from the NGS OPUS website for GPS static occupations utilizing a Trimble R10 at a set base station and a second R10 in conjunction with a Trimble TSC3 with Trimble Access software and RTK methods.

Established primary control and ties to found monuments utilizing said RTK methods and Trimble R10 equipment. From which, utilized classical terrestrial methods and said Trimble S7 robotic instrument with said Trimble TSC3 data collector to establish all remaining control, monument ties and topographic locations.

Established the west line of Section 15, said Township and Range, by holding the found monuments at the Northwest corner and West One-quarter corner of said Section 15. Held found monuments at the northwest, southwest and southeast corners of QUEEN'S BRANCH SUBDIVISION, said records, to establish the west and south boundaries thereof. Utilizing found monuments and said established boundaries in conjunction with Instruments Numbered 2017-033549 and 2017-033551, said records, the exterior boundaries of the pre-adjusted tracts were resolved. From which, established the adjusted resultant tracts as depicted on the accompanying map, pursuant to the approved Jackson County Development Services File Number 439-17-00076-SUB and the subsequent Instrument Numbered 2018-015530, said records.
