## **SURVEY NARRATIVE:**

PURPOSE: To identify and monument the property corners of that property described in Instrument No. 2018-028961 Jackson County Records.

PROCEDURE: Tying the found Kaiser pins per F.S. 9814 and 10753 the monuments fit per measurements shown on map, and did fit well with the center line monument at the intersection of Platt and Loto Streets. A lead plug and brass tag, not readable and origin unfound, was found near the intersection of Loto Street and South Royal Avenue was not held.
