SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

<u>PURPOSE</u>: TO SURVEY AND MONUMENT THE PROPERTY LINE ADJUSTMENT OF THESE PARCELS PER THE CLIENTS REQUEST AS APPROVED BY THE JACKSONVILLE PLANNING DEPARTMENT IN FILE NO. 2018–206.

PROCEDURE: CONTROL FROM COUNTY SURVEYORS FILE NO. 22191 WAS USED AND VERIFIED TO ESTABLISH THE NORTH AND EAST LINE. THE FOUND QUARTER CORNER AS SHOWN HEREON AND THE FOUND 5/8" IRON PIN AT THE SOUTHEAST CORNER OF THE TRACT WERE HELD TO ESTABLISH THE SOUTH LINE. THE RIGHT OF WAY OF APPLEGATE STREET WAS ESTABLISHED FROM FOUND MONUMENTS AT THE SOUTHWEST AND NORTHWEST CORNERS OF THE TRACT AS SHOWN HEREON. A PORTION OF THE COMMON LINE BETWEEN THE PARCELS WAS MOVED TO ESTABLISH THE NEW BOUNDARY AS SHOWN HEREON.
