SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

TO SURVEY AND MONUMENT THAT PROPERTY AS DESCRIBED AS PARCEL 1 IN INST. NO. 2012-008202 AS REQUESTED BY CLIENT.

PROCEDURE: THE NORTH LINE WAS DETERMINED BY TYING THE FOUR QUARTER CORNERS OF SECTION 1 AND THE SOUTHWEST SECTION CORNER OF 1. THE SOUTHWEST QUARTER WAS BROKEN DOWN AS SHOWN. THE NORTH LINE OF THE SUBJECT TRACT IS THE NORTH LINE OF THE SOUTH HALF OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 1, TOWNSHIP 38 SOUTH, RANGE 1 WEST, WILLAMETTE MERIDIAN. THE EAST LINE OF THE SUBJECT PARCEL IS THE CENTERLINE OF THE TALENT IRRIGATION DISTRICT'S EAST CANAL. THIS LINE WAS NOT TIED ON THIS SURVEY EXCEPT AT THE INTERSECTION OF THE NORTH LINE WITH THE CANAL TO ESTABLISH THE OFFSET DISTANCE FOR THE WITNESS MONUMENT SET ON SAID NORTH LINE. THE SOUTH LINE WAS ESTABLISHED BETWEEN THE FOUND MONUMENTS ON EITHER END OF THE LINE. THE WEST LINE OF TAX LOT 201 WAS ESTABLISHED BY THE TIED SECTION CORNER COMMON TO SECTIONS 1, 2, 11, & 12 AS WELL AS THE QUARTER CORNERS OF COMMON TO SECTIONS 1 & 2 AND SECTIONS 11 & 12. THE WEST LINE OF TAX LOT 800 WAS ESTABLISHED FROM THE TIED DLC CORNERS DEFINING THE EAST LINE OF DLC NO. 81 AND THE TIED MONUMENTS AS SHOWN DEFINING THE EAST RIGHT-OF-WAY LINE OF PAYNE ROAD.

THERE IS SOME AMBIGUITY IN THE NORTH LINE OF TAX LOT 800. THE DEED IN THIS SURVEY, INSTRUMENT NO. 2012-8202, CALLS FOR THE LINE TO RUN DUE WEST. THE DEED FOR THE ABUTTING PROPERTY TO THE NORTH OF TAX LOT 800 (TAX LOT 100) CALLS FOR THE LINE TO RUN PARALLEL WITH THE NORTH LINE OF SECTION 11. IN MY RESEARCH, IT APPEARS THAT THE DESCRIPTIONS WRITTEN FOR TAX LOT 100 IN INST. NO. 2012-22988 CALL FOR THE LINE TO BE PARALLEL WITH THE NORTH LINE OF SECTION 11, WHILE THE DESCRIPTIONS IN DEEDS THAT INCLUDE TAX LOT 800 CALL FOR THE CARDINAL DIRECTION. THE DOCUMENTS I FOUND TO CALL THE CARDINAL DIRECTION ARE: INST. NO. 2012-8202, VOL. 382 PAGE 476, VOL. 130 PAGE 440, AND VOL. 122 PAGE 161.
