Utilizing the boundary established per filed survey no. 22574 and the found monuments set there on, of which fit well with their respective record positions. The southwest corner thereof was found and held per filed survey no. 12684.

Note: The existing 40' wide Water Easement per 2019-004369 and the 40' wide private access/utility easement granted hereon are coincident in location and area as depicted.

Monuments were set at the new parcel corners as depicted.
