SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

<u>PURPOSE:</u> TO SURVEY, DESCRIBE, MONUMENT AND PREPARE A MAP OF SURVEY FOR PROPERTY LINE ADJUSTMENT PER THE CLIENTS REQUEST AND AS APPROVED BY JACKSON COUNTY PLANNING, FILE NO. 439–18–00073–SUB.

PROCEDURE: THE FOUND MONUMENTS SET ON SURVEY NUMBER 9071 WERE HELD TO ESTABLISH THE NORTHEASTERLY LINE. A SEARCH FOR RECORDS WAS CONDUCTED AT THE JACKSON COUNTY ROADS DEPARTMENT AND NO INFORMATION REGARDING THE RIGHT OF WAY OF PLEASANT CREEK ROAD WAS FOUND IN THIS AREA. I FOUND INFORMATION TO THE NORTH AND SOUTH OF THIS AREA WITH A RIGHT OF WAY WIDTH OF 30 FEET TO THE EAST. I REVIEWED THE ROLL MAP OF PLEASANT CREEK ROAD AND FOUND HANDWRITTEN BEARINGS ON A P-LINE DRAWN ON THE MAP. THESE BEARINGS MATCH (WITH ROTATION) THE BEARINGS AS SHOWN ON SURVEY NO. 8136. THERE IS NO RIGHT OF WAY INFORMATION ON THE ROLL MAP IN THIS AREA. THE RIGHT OF WAY SHOWN IS FROM A RECENTLY RECORDED SURVEY NUMBER 22759.

THE UNADJUSTED PORTION OF THE LINE COMMON TO BOTH PROPERTIES WAS HELD PARALLEL TO THE NORTHEASTERLY LINE OF TAX LOT 602 THROUGH THE FOUND MONUMENT AT THE ANGLE POINT IN THAT LINE. I SET A MONUMENT AT A DISTANCE OF 30 FEET PERPENDICULAR WITH THE ESTABLISHED P-LINE AS SHOWN ON SURVEY NUMBERS 8136 AND 9071.

THE CENTER-QUARTER WAS SEARCHED FOR AND NOT FOUND. IT WAS SET PER S/N 8136 AND WAS SEARCHED FOR ON SURVEY NUMBER 10934 AND NOT FOUND. BEARING TREES AS SHOWN ON SURVEY NUMBER 8136 WERE SEARCHED FOR AND NOT FOUND. I SET A NEW PIN AT RECORD DISTANCE OF 95.85 FEET FROM THE FOUND PIN PER SURVEY NUMBER 8136 ON A LINE TO THE SOUTH QUARTER CORNER OF SECTION 22. THE NEW LINE WAS ESTABLISHED BETWEEN THE CENTER-QUARTER CORNER AND THE FOUND MONUMENT ON THE SOUTHWESTERLY LINE AS SHOWN HEREON. TAX LOT 509 WAS UNSURVEYED PER ORS 92.055.
