

*** SURVEYOR'S CERTIFICATE ***

I, Bary D. Kaiser, a duly registered professional land surveyor of the State of Oregon, do hereby certify that I have correctly surveyed and marked with proper monuments as provided by law the attached partition plat, said plat being a correct representation of the same, and the following is an accurate description of the boundary lines:

Commencing at a 5/8" rebar with plastic cap found set for the Northwesterly corner of Parcel No. 1 of Partition Plat recorded July 22, 2005 as Partition Plat No. P-48-2005 of the "Records of Partition Plats" in Jackson County, Oregon, and filed as Survey No. 18825 in the Office of the County Survey; Thence along the Northerly boundary of said Parcel No. 1, North 89° 43' 08" East, 13.94 feet to a 5/8" rebar with plastic cap set for the Southeasterly corner of tract described in Instrument No. 97-48270 of the Official Records of said Couty for THE INITIAL POINT OF BEGINNING; Thence along the Northeasterly boundary of said tract, North 42° 42' 42" West, 26.31 feet to intersect the Easterly right-of-way line of Walnut Lane at a 5/8" rebar with plastic cap set for the most Northerly corner of said tract; Thence along the Easterly right-of-way line of Walnut Lane as follows: 99.105 feet along the arc of a 220.00 foot radius curve to the left (long chord bears North 26° 51' 39" West, 98.27 feet) to a 5/8" rebar with plastic cap set; Thence North 39° 45' 58" West, 140.815 feet (record = North 39° 46' 45" West, 140.87 feet) to a 5/8" rebar found set; Thence 4.22 feet along the arc of a 820.00 foot radius curve to the left (long chord bears North 39° 54' 49" West, 4.22 feet); Thence leaving said Lane line along the Northerly boundary of tract described in Instrument No. 2016-037597 of the Official Records of said County, North 86° 30' 17" East, 191.30 feet (record = North 86° 28' 58" East, 191.73 feet) to an angle point; Thence continuing along said boundary, South 0° 01' 21" West, 26.62 feet (record = 26.57 feet) to a 5/8" rebar with plastic cap found set for an angle point; Thence South 85° 51' 23" East, 236.11 feet (record = South 85° 51' 32" East, 235.36 feet) to intersect the Westerly right-of-way line of Roque River Drive, at the Northeast corner of said tract; Thence along said Drive line, South 1° 48' 10" East, 177.41 feet to a 5/8" rebar with plastic cap set for an angle point; Thence continuing along said Drive line, South 23° 12' 20" West, 8.51 feet to a 5/8" rebar with plastic cap found set for the Northeast corner of said Parcel No. 1, also being the Southeast corner of said tract; Thence leaving said Drive line along the Northerly boundary of said Parcel No. 1, South 89' 43' 08" West, 274.23 feet to THE INITIAL POINT OF BEGINNING.


