
MAP OF SURVEY

SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250 OREGON REVISED STATUTES

TO SURVEY AND MONUMENT THAT TRACT OF LAND AS DESCRIBED IN INSTRUMENT NUMBER 2019-5696 OF THE OFFICIAL RECORDS OF JACKSON COUNTY, OREGON, PER THE REQUEST OF THE CLIENT.

PROCEDURE:
THE NORTH, SOUTH AND EAST BOUNDARY LINES OF THE SUBJECT PROPERTY WERE PREVIOUSLY SURVEYED AND MONUMENTED IN SURVEY NUMBER 2193. THOSE MONUMENTS WERE RECOVERED AND THEIR POSITIONS WERE HELD. RECORD DEED DIMENSIONS WERE USED, AS SHOWN HEREON, TO RESOLVE THE LOCATION OF AND MONUMENT THE NORTHWEST AND SOUTHWEST CORNERS OF THE SUBJECT PROPERTY. THE LEGAL DESCRIPTION CONTAINED WITHIN THE VESTING DEED OF THE SUBJECT PROPERTY, INSTRUMENT NUMBER 2019—5696, USES SURVEY NUMBER 2193 FOR THE BASIS OF THE DESCRIPTION. SAID LEGAL DESCRIPTION DOES NOT SPECIFICALLY CALL TO OR FOR THE MONUMENTS SET IN SURVEY NUMBER 2193, BUT BY TRACING THE METES AND BOUNDS FROM THE DESCRIPTION ALONG THE SURVEYED LINES OF SURVEY NUMBER 2193, YOU ARRIVE AT THE SUBJECT PROPERTY.

THIS SURVEY WAS PERFORMED IN FEBRUARY OF 2020 AND USES INTERNATIONAL FEET UNITS. THE SURVEY EQUIPMENT USED CONSISTED OF A TRIMBLE 5603 ROBOTIC TOTAL STATION, AND A TRIMBLE TSC3 CONTROLLER RUNNING TRIMBLE ACCESS SOFTWARE.


