
ASSESSOR'S MAP NO. 39 1E 14 BB, TAX LOT 418

SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

TO SURVEY AND MONUMENT THE BOUNDARY OF PARCEL NO. 2 OF PARTITION PLAT NO. P-87-1992, FILED AS SURVEY NO. 13130 IN THE OFFICE OF THE JACKSON COUNTY SURVEYOR, AND DESCRIBED IN INSTRUMENT NUMBER 2019-031782 OF THE OFFICIAL RECORDS OF JACKSON COUNTY, OREGON.

USING A TRIMBLE S-6 ROBOTIC TOTAL STATION AND TRIMBLE R-10 GPS RECEIVERS, I RECOVERED AND TIED EXISTING MONUMENTS OF RECORD AS SHOWN HEREIN. THE RECOVERED CENTERLINE MONUMENTS ALONG CLAY STREET WERE HELD, AND EXTENDED, TO ESTABLISH THE EAST RIGHT-OF-WAY OF CLAY STREET. THE EXISTING 5/8" IRON RODS SET ON SURVEY NUMBER 12767 ALONG THE NORTHERLY BOUNDARY OF OAK CREEK SUBDIVISION WERE HELD AND EXTENDED TO INTERSECT SAID RIGHT—OF—WAY LINE. THE RECOVERED 5/8" IRON PIN WAS HELD FOR THE SOUTHWESTERLY CORNER OF THE SUBJECT PROPERTY. THE WESTERLY LINE WAS PROPORTIONED FROM SAID CORNER TO SAID INTERSECTION. THE SOUTHERLY LINE WAS ESTABLISHED BY HOLDING THE BEARING PARALLEL WITH THE RECOVERED CENTERLINE MONUMENTS ALONG TAKELMA WAY. THE EASTERLY LINE WAS ESTABLISHED BY HOLDING THE RECOVERED MONUMENTS AND PROPORTIONING AS SHOWN HEREIN. THE NORTHERLY LINE WAS ESTABLISHED FROM THE AFOREMENTIONED PROPORTIONED POSITIONS.
