PURPOSE OF SURVEY:

TO PERPETUATE THE LOCATION OF FOUND MONUMENTS OF RECORD THAT MAY BE REMOVED, DESTROYED OR DISTURBED BY CONSTRUCTION PER O.R.S. 209.150. ALSO TO RETRACE THE RIGHT-OF-WAY OF FOOTHILL AND COREY ROAD IN THE VICINITY OF THEIR INTERSECTION.

PROCEDURE:

UTILIZING A TRIMBLE R10 GNSS RECEIVER REFERENCED TO THE OREGON REAL-TIME GNSS NETWORK (ORGN), AND OCCUPYING CONTROL WITH A TRIMBLE S6 TOTAL STATION, MONUMENTS WERE RECOVERED AS SHOWN HEREON. REDUNDANT OBSERVATIONS WERE PERFORMED WITH SAID R10 RECEIVER AND SAID TOTAL STATION TO MAINTAIN REQUIRED LEVEL OF

CONTROL NARRATNE:

STATIC OCCUPATIONS WERE PERFORMED ON PRIMARY CONTROL POINTS (#1-3), WITH CTPT, AN ORGN CORS STATION, AND NETRS, A REFERENCE STATION OPERATED BY THE JACKSON COUNTY SURVEYOR, HELD FOR POSITION IN A NETWORK ADJUSTMENT POST-PROCESSED THROUGH TRIMBLE BUSINESS CENTER. SAID CONTROL WAS ORIGINALLY SET BY A JACKSON COUNTY ROAD DEPARTMENT SURVEY CREW IN THE EARLY 2000s.

RIGHT-OF-WAY DETERMINATION NARRATIVE

FOOTHILL ROAD:

THE RIGHT-OF-WAY OF FOOTHILL ROAD ALIGNMENT 'FHR' SOUTH OF POINT #219 HAS BEEN DETERMINED BY LEGALIZATION PER ORDER 104-19 OF THE JACKSON COUNTY BOARD OF COMMISSIONERS, RECORDED AS INSTRUMENT NO. 2019-017930 OF THE OFFICIAL RECORDS OF JACKSON COUNTY, OREGON, AND HAS BEEN MONUMENTED PER S/N 22977, ON FILE WITH THE COUNTY SURVEYOR, JACKSON COUNTY, OREGON.

NORTHWESTERLY FROM POINT #219, ALIGNMENT 'FHR' IS A PROPOSED ALIGNMENT TO BE USED TO ACQUIRE RIGHT-OF-WAY FOR AN EXTENSION OF FOOTHILL ROAD TO INTERSECT WITH A PROPOSED ROUNDABOUT IN LAKE OF THE WOODS HIGHWAY (OR140) AT ATLANTIC AVENUE.

ADDITIONALLY, JACKSON COUNTY PURCHASED RIGHT-OF-WAY AT THE SOUTHWESTERLY CORNER OF COREY ROAD AND FOOTHILL ROAD PER INSTRUMENT NO. 91-18682. NO RECORD WAS FOUND OF THIS PURCHASE BEING MONUMENTED, AND NO MONUMENTS WERE FOUND AT THE CALCULATED POSITIONS. THE CENTERLINE UTILIZED IN THIS PURCHASE. BEING ALSO THAT SHOWN ON S/N 16421, IS SHOWN HEREON AS CENTERLINE 'FH' AND IS NOT COINCIDENT WITH THE LINE RUNNING BETWEEN SECTIONS 27 AND 28. HOWEVER, SAID SECTION LINE WAS HELD AS THE CENTERLINE PER S/N 22977, RESULTING IN AN OVERLAP BETWEEN THE LEGALIZED RIGHT-OF-WAY AND THE RIGHT-OF-WAY PER INSTRUMENT NO. 91-18682. POINT #30200 WAS HELD AS STATION 306+67.52 OF SAID 'FH' CENTERLINE, WITH POINT #30106 BEING HELD AS A BACK BEARING OF SAID CENTERLINE.

COREY ROAD:

THE RIGHT-OF-WAY OF WHAT IS CURRENTLY KNOWN AS COREY ROAD WAS CREATED BY A COURT ORDER DATED MAY 3, 1917, AS A RESULT OF A PETITION BY O.A. TURPIN, ET. AL. THE SURVEYOR'S REPORT, DATED APRIL 30, 1917, DESCRIBED A ROAD FOLLOWING THE SIXTEENTH-LINE RUNNING WEST TO EAST THROUGH A PORTION OF SECTIONS 28 AND 27, TOWNSHIP 36 SOUTH, RANGE 1 WEST. THE DOCUMENTS ESTABLISHING THIS ROAD CAN BE FOUND IN COMMISSIONER'S JOURNAL VOLUME 16, PAGES 328 THROUGH 350 AS RECORDED IN THE OFFICE OF THE JACKSON COUNTY CLERK.

SURVEY NO. 1847 AND 1859, FILED IN 1962, DETERMINED THE CENTERLINE OF COREY ROAD BASED ON "EXISTING CONDITIONS", WITH THE NARRATIVE OF SAID SN 1859 STATING THAT SAID CENTERLINE "ACCORDING TO RECORDS, PREVIOUSLY FOLLOWED THE 1/16 LINE". ALL SURVEYS PERFORMED ALONG THIS SECTION OF COREY ROAD SINCE THAT TIME HAVE UTILIZED THE MONUMENTATION SET BY SAID 1962 SURVEYS AS EVIDENCE OF THE RIGHT-OF-WAY. HOWEVER, WITH NO CORRESPONDING LEGAL DOCUMENTATION TO ALTER THE RIGHT-OF-WAY, THE PETITION HOLDS UNTIL THE TRUE RIGHT-OF-WAY IS ALTERED BY METHODS AS ALLOWED PER STATUTE.

BOTH OF THE AFOREMENTIOED RIGHT-OF-WAYS FOR COREY ROAD WERE DETERMINED AND ARE SHOWN HEREON. THE ORIGINAL 1917 RIGHT-OF-WAY WAS DETERMINED BY STANDARD INTERSECTION AND PROPORTIONING METHODS PER THE BLM "MANUAL OF SURVEYING INSTRUCTIONS". NO RECORD OF THE CALLED-FOR SIXTEENTH-CORNERS BEING FOUND, AND THE 1962 RIGHT-OF-WAY BEING DETERMINED BY FOUND MONUMENTS FROM SURVEYS 1847, 1859, AND 19130.


IT SHOULD BE NOTED THAT THE RIGHT-OF-WAY PER SAID 1962 SURVEYS IS A BETTER FIT TO THE PHYSICAL IMPROVEMENTS OF COREY ROAD AND PRIVATE IMPROVEMENTS BY ADJOINERS THAN THE ORIGINAL AND CURRENTLY LEGAL RIGHT-OF-WAY. LEGALIZATION IS RECOMMENDED FOR THIS SECTION OF COREY ROAD. AS IT CLEARLY MEETS THE CONDITION AS SET FORTH IN ORS 368.201(3).




