PROCEDURE: Records utilized: Instrument Number 2017-035594 of the Official Records of Jackson County, Oregon; the plat STERLING ESTATES, filed for record on July 6, 2006 and recorded in Volume 32 at Page 52 of the Plat Records of Jackson County, Oregon (and filed as Survey Number 19250 in the Office of the Jackson County Surveyor). Equipment/Software utilized: Trimble S7 Robotic Instrument, TSC7 Data Collector with Trimble Access Software, Trimble Business Center, and Trimble Terramodel.

The subject tract of land is described in said Instrument Number 2017-035594 as Lot 25 of said STERLING ESTATES. Searched and tied all found monuments as depicted and noted hereon. From which, computed the resultant boundary of said Lot 25 utilizing found monument and record data as follows:

Utilized said Trimble 57 and TSC7 Data Collector, in conjunction with classic terrestrial methods to tie into the centerline monuments on Ruby Meadows Drive, as established per said plat STERLING ESTATES. From which, established primary and secondary control and tied monuments per said plat STERLING ESTATES. Thence, computed the centerline of said Ruby Meadows Drive and rights-of-way thereof. From which resolved the location of the exterior boundaries of the subject tract of land.

Certain monuments per STERLING ESTATES were found disturbed and out of position, and were not held or utilized to resolve the subject boundary.


