PROCEDURE: UTILIZING RECORD MAPS AND DEED INFORMATION NOTED ON THE MAP, A FIELD SURVEY WAS MADE UTILIZING A CARLSON BRX5 GNSS RECEIVER, AND CARLSON SURVEYOR 2 DATA COLLECTOR CONNECTED TO THE OREGON REAL TIME GEODETIC NETWORK (ORGN). REDUNDANT MEASUREMENTS WERE MADE TO FOUND AND SET MONUMENTS AND THEIR POSITIONS ARE REPORTED AS SHOWN HEREON. BOUNDARY DETERMINATIONS WERE MADE AS FOLLOWS:

THE CENTERLINE MONUMENTS PER BLOSSOM HILL TERRACE UNIT NO. 5 SUBDIVISION WERE PAVED OVER SO CENTERLINE REFERENCE POINT NOTES PER THE CITY OF MEDFORD SURVEY RECORDS WERE UTILIZED TO CALCULATE THE POSITION OF THESE MONUMENTS. THESE CALCULATED POSITIONS, AS WELL AS AN ORIGINAL MONUMENT ON THE EAST LINE OF THE SUBJECT TRACT FIT THE RECORD GEOMETRY OF SAID BLOSSOM HILL TERRACE UNIT NO 5 SUBDIVISION. 
