PURPOSE: TO ADJUST AND MONUMENT THOSE TRACTS OF LAND DESCRIBED IN DOCUMENT NUMBERS 96-09067, 96-09073 AND 2019-040488 OF THE OFFICIAL RECORDS OF JACKSON COUNTY, OREGON THESE PROPERTY LINE ADJUSTMENTS WERE APPROVED IN JACKSON COUNTY DEVELOPMENT SERVICES PLANNING ACTIONS: 439-19-00031-SUB, 439-19-0032-SUB, 439-19-00033-SUB,439-19-00034-SUB, 439-19-00035-SUB, 439-19-00057-SUB AND 439-19-00058-SUB.

PROCEDURE: THIS SURVEY WAS CONDUCTED USING LEICA TS12 AND TCRP 1203 ROBOTIC TOTAL STATIONS, DISTANCE PRISMS, LEICA CS15 DATA COLLECTORS AND JAVAD TRIUMPH 2, G.P.S. RECEIVERS. THE BASIS OF BEARING FOR THIS SURVEY IS THE WEST LINE OF SECTION 26, TOWNSHIP 38 SOUTH, RANGE 2 EAST OF THE WILLAMETTE MERIDIAN, JACKSON COUNTY, OREGON BETWEEN THE NORTHWEST SECTION AND WEST QUARTER CORNERS AS DETERMINED BY SURVEY NUMBER 6654 FILED IN THE JACKSON COUNTY, OREGON SURVEYORS OFFICE.

> PAGE THREE OF THIS PLAT REPRESENTS THE NINE PARCELS OF LAND BEING ADJUSTED. THESE INCLUDE DOCUMENT NUMBER 2019-040488, PARCEL 2 OF PARTITION PLAT NUMBER P-38-2018, RECORDED IN VOLUME 29, PAGE 38 OF PARTITION PLATS OF JACKSON COUNTY, OREGON AND SEVEN PARCELS OF LAND THAT WERE DETERMINED TO BE LAWFULLY CREATED UNITS OF LAND PER JACKSON COUNTY PLANNING FILE NUMBER 439-18-00097-ZON. THESE SEVEN PARCELS INCLUDE MULTIPLE U.S. GENERAL LAND OFFICE PATENTS; 5541 (PARCEL 1), PATENT 384570 (PARCEL 2), PATENT 2582 (PARCEL 3), A REMAINDER OF PATENT 470602 (PARCEL 4), A REMAINDER OF PATENT 1464 (PARCEL 5), A REMAINDER OF PATENT 557 (PARCEL 6) AND A REMAINDER OF PATENT 1868 (PARCEL 7).

THE SECTION AND QUARTER CORNERS OF SECTION 26 AND THE NORTH QUARTER CORNER OF SECTION 27, TOWNSHIP 38 SOUTH, RANGE 2 EAST OF THE WILLAMETTE MERIDIAN, JACKSON COUNTY, OREGON, WERE LOCATED TO HELP PREPARE THIS SURVEY.

DEAD INDIAN MEMORIAL ROAD WAS DETERMINED BY UTILIZING CALLS FROM JACKSON COUNTY ROAD ENGINEERS RECORD 320, DATED JULY 2, 1930, FILED SURVEY 3306 AND PARTITION PLAT P-48-1992.

OLD DEAD INDIAN ROAD (60-FEET WIDE) WAS CONVEYED TO JACKSON COUNTY, OREGON IN ROAD RECORD VOLUME 3, PAGE 229, WHICH INCLUDES SPECIFIC QUITCLAIM LANGUAGE, WHOSE INTENT APPEARS TO CONVEY FEE TITLE. THIS ROAD DESCRIPTION BEGINS 250 FEET FROM THE SOUTHEAST CORNER OF SECTION 24, TOWNSHIP 38 SOUTH, RANGE 2 EAST OF THE WILLAMETTE MERIDIAN, JACKSON COUNTY, OREGON AND REFERENCES THE NORTHEAST CORNER OF SECTION 26 OF SAID TOWNSHIP AND RANGE AND THE NORTHWEST CORNER OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 26. SAID DOCUMENT ALSO REFERENCES A BLACK OAK TREE, SOUTHWEST AND YELLOW PINE TREE, NORTHEAST OF THE TERMINATION POINT. AFTER LAYING OUT THE DESCRIPTION OF SAID DOCUMENT AND COMPARING IT TO CALLS MADE TO THE "AVERAGE CENTERLINE OF TRAVELED WAY OF OLD DEAD INDIAN ROAD, PRIOR TO 1930" SHOWN ON SURVEY NUMBER 7588, IT WAS DETERMINED THAT THE TERMINATION POINT SHOULD HAVE BEEN IN THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER WITH A CALL TO THE NORTHWEST CORNER OF SAID QUARTER, QUARTER. A ROTATION WAS THEN MADE, HOLDING THE NORTHEAST CORNER OF SAID SECTION 26 AND THE NORTHWEST CORNER OF SAID QUARTER, QUARTER. AN EXTENSIVE SEARCH FOR THESE TREES WAS MADE BY MYSELF, TOGETHER WITH THE HELP OF THE COUNTY SURVEYOR, AND ARE DETERMINED TO BE LOST. FURTHERMORE, DOCUMENT NUMBER 78-16517 CREATES A 25-FOOT WIDE PRIVATE ROAD THAT FOLLOWS THE CURRENT TRAVELED WAY. HOWEVER, THIS DOCUMENT, NOR SURVEY NUMBER 7340, WHICH SHOWS THE LOCATION OF THIS DOCUMENT, EXPLAINS THE CORRELATION WITH JACKSON COUNTY ROAD RECORD VOLUME 3, PAGE 229. OLD DEAD INDIAN ROAD IS LOCATABLE, HOWEVER, ITS LOCATION IS VERY UNCERTAIN. DUE TO THE DIFFERENCE IN WIDTH OF THE COUNTY ROADS RECORD AND DOCUMENT 78-16517, IT IS UNCERTAIN IF THESE DOCUMENTS WERE TO COINCIDE WITH EACH OTHER. A ROAD VACATION OF OLD DEAD INDIAN ROAD IS WARRANTED TO RESOLVE ANY AND ALL TITLE ISSUES ALONG COUNTY ROAD RECORD VOLUME 3, PAGE 229.

COVE ROAD WAS DEEDED TO THE COUNTY IN VOLUME 193, PAGE 282, JACKSON COUNTY, OREGON DEED RECORDS. THE CALLS FROM SAID DOCUMENT ALONG WITH FILED SURVEYS 5069, 12499, 14442 AND 22699 HELPED TO DEFINE THE LOCATION.

PARCELS 7 AND 9 WERE SURVEYED AND MONUMENTED PER O.R.S. 92.060. PARCELS 1 TO 6 AND 8 WERE UNSURVEYED AND UNMONUMENTED PER O.R.S. 92.055.
