

SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250, OREGON REVISED STATUTES

PURPOSE: Pursuant to Client's request and direction, perform a boundary survey, recover existing monuments, perform a boundary resolution, establish monuments at boundary corners for the Property Line Adjustment per the City of Central Point Planning File Number LLA-20003, and to draft the resultant tracts and file a Map of Survey in the office of the Jackson County Surveyor.

PROCEDURE: Records Utilized: Volume 353 at Page 33, volume 404 at Page 368, Volume 468 at Page 318, Volume 469 at Page 65 and Volume 472 at Page 275, all of the Deed Records of Jackson County, Oregon; Instruments Numbered 78-13145, 78-13475, 93-43748, 93-43751 and 2008-020501, all of the Official Records of Jackson County, Oregon; Oregon State Highway Department (OSHD, now known as Oregon Department of Transportation (ODOT)), Drawing Number 8B-08-23; ODOT Drawing Number 01A-13-26; plat recorded November 15, 1993, as Partition Plat Number P-98-1993 of the Records of Partition Plats of Jackson County, Oregon, Index Volume 4 at Page 98, and filed as Survey Number 13719 in the office of the Jackson County Surveyor; plat recorded May 7, 2008, as Partition Plat Number P-30-2008 of the Records of Partition Plats of Jackson County, Oregon, Index Volume 4 at Page 98, and filed as Survey Number 20021 in the office of the Jackson County Surveyor; Jackson County Re-establishment Notes and Surveys Numbered 175, 364, 718, 1163, 1829, 2794, 8164, 19931, 20511 and 22960, all as filed in the office of the Jackson County Surveyor. Equipment/Software utilized: Trimble RIO 6NSS equipment, Trimble 57 robotic total station, Trimble SXIO robotic total station and scanner, Trimble TSC7 data collectors with Trimble Access Software; Trimble Business Center and Trimble Terramodel. Linear unit (horizontal) is International Foot (lift); Linear unit (vertical) is U.S. Survey Foot (usft); Vertical datum is the North American Datum of 1988 (NAVD88); Geodetic Information: Datum is the North American Datum (NAD) of 1983 (2011) Epoch 2010.00; System is the Oregon Coordinate Reference System; Zone is the Grants Pass-Ashland (Refer to ORS, Chapter 93.312(c)).

Subject tracts are described per said Volume 353 at Page 33, Volume 404 at Page 368, Instrument Number 93-43751 and Partition Plat Number P-30-2008 (Survey Number 20021) for original property for Tract I, and Instrument Number 2008-020501 and said Partition Plat Number P-30-2008 for original property for Tract 2. To resolve these original boundaries, the following was performed: Resolved centerline and rights-of-way of East Pine Street utilizing found monuments and Surveys Numbered 13985, 20666 and 22960; Resolved centerline and rights-of-way of North Tenth Street utilizing found monuments, Instruments Numbered 78-13145 and 78-13475, and Surveys Numbered 7375, 7689 and 13985; Resolved westerly right-of-way of Interstate 5 utilizing found monuments, OSHD Drawing Number 8B-08-23, ODOT Drawing Number 01A-13-26/Survey Number 13985, and Surveys Numbered 1829, 2794, 13719, 20021 and 20511; Resolved location of a private drive from North Tenth Street, northerly, utilizing found monuments, Instrument Number 93-43748 and Surveys Numbered 13719 and 20511; Utilizing said resolved rights-of-way and private drive, resolved the location of the northerly, easterly and westerly boundaries, and a portion of the southerly boundary said subject tract of land for the original property for Tract I; Resolved the remaining subject tracts boundaries utilizing found monuments, said Volume 353 at Page 33, Volume 404 at Page 368, Instruments Numbered 93-43751 and 2008-020501, and Surveys Numbered 175, 364, 1163, 2794, 8164, 19931 and 20021.

Utilizing said boundary resolutions and said City of Central Point Planning File Number LLA-20003, computed the adjusted property line and the resultant Tracts I and 2, as depicted on Sheet I hereof.

Completed establishing monuments, as depicted on said Sheet I hereof, on March I, 2021.


