SURVEY NARRATIVE TO COMPLY WITH 209.250 O.R.S.

PURPOSE OF SURVEY:

TO MONUMENT A RIGHT-OF-WAY ACQUISITION DESCRIBED IN INSTRUMENT NO. 2020-11751 PER THE REQUIREMENTS OF ORS 368.106.

PROCEDURE:

PRIMARY CONTROL WORK WAS PERFORMED BY OBEC CONSULTING ENGINEERS, INC. ON A CONTRACT WITH JACKSON COUNTY. FINAL CONTROL VALUES WERE PROVIDED TO THIS OFFICE ON DECEMBER 12, 2019. SAID CONTROL WAS UTILIZED FOR THE DESIGN AND CONSTRUCTION OF A PROJECT TO REPLACE THE EXISTING BRIDGE OVER TRAIL CREEK ON ELDER MILL ROAD. UTILIZING SAID CONTROL, ADDITIONAL CONTROL WAS ESTABLISHED BY ADKINS ENGINEERING & SURVEYING DURING THE COURSE OF THE PROJECT, AND BY THIS OFFICE AFTER PROJECT COMPLETION AS SHOWN HEREON.

SAID CONTROL WAS OCCUPIED TO DETERMINE THE COORDINATE LOCATIONS OF THOSE MONUMENTS DEFINING THE BASIS OF BEARING AS SHOWN HEREON. HOLDING SAID COORDINATE LOCATIONS, A ROTATION ADJUSTMENT OF -0.23'47" WAS APPLIED TO THE DEED BEARINGS TO DETERMINE THE LOCATION OF ACQUIRED RIGHT-OF-WAY. MONUMENTS WERE THEN ESTABLISHED AS SHOWN HEREON.

RIGHT-OF-WAY DETERMINATION NARRATIVE

THE ORIGINAL CENTERLINE OF "A COUNTY ROAD IN TRAIL CREEK PRECINCT" WAS PETITIONED, SURVEYED AND ACCEPTED BY THE COURT IN 1885, PER COMMISSIONER'S JOURNAL VOLUME 6, PAGES 381, 397-399 AND ROAD RECORDS VOLUME 2, PAGES 68-69. LACKING A SPECIFIED WIDTH IN THESE DOCUMENTS, A STATUTORY WIDTH OF 60 FEET WAS USED. THE SURVEYOR'S REPORT OF 1885 LACKS SUFFICIENT CALLS TO SECTIONAL MONUMENTATION AND BEARING TREES TO ALLOW FOR RETRACEMENT OF ANY REASONABLE ACCURACY. RECORD BEARINGS AND DISTANCES OF SAID SURVEYOR'S REPORT FIT POORLY WITH THE SHAPE OF THE

AERIAL IMAGERY FROM 1991, AND THE FACT THAT THE EXISTING BRIDGE WAS BUILT IN 1968, PROVIDE EVIDENCE THAT THE CURRENT ROAD LOCATION IN THIS AREA HAS NOT SUBSTANTIALLY CHANGED FOR A NUMBER OF DECADES.

BASED ON THE AVAILABLE EVIDENCE, THE ROAD LOCATION PRIOR TO CONSTRUCTION WAS USED TO LOCATE ELDER MILL ROAD FOR THE PURPOSES OF DETERMINING ADDITIONAL RIGHT-OF-WAY NEEDS. PURSUANT TO THE CONDITIONS OF ORS 368.201, LEGALIZATION WAS RECOMMENDED TO THE ROAD DEPARTMENT TO FULLY VEST THE RIGHT-OF-WAY LOCATION OF ELDER MILL ROAD.




