THE DATA WAS ANALYZED AND SURVEYED AS SHOWN AND AS DESCRIBED AS

- THE PROPERTIES SHARED A COMMON LINE, BEING THE NORTH LINE OF ROGUE VALLEY HEIGHTS EXT. SUBDIVISION AND SOUTH LINE OF SPRINGBROOK SUBDIVISION. THIS LINE WAS RESOLVED BY THE PERPETUATED MONUMENT SHOWN AS 401M AND A CALCULATED POINT 5' SOUTH OF MONUMENT 408M AND SUPPORTED BY FOUND MONUMENT PER SURVEY 10533 SHOWN. SINCE THE VACATED ROAD (JCOR 21-048375, 90-20819) WAS DEDICATED PER SPRINGBROOK SUBDIVISION, THE 30' WIDE ROAD VACATED ATTACHES ENTIRELY TO THE PROPERTY
- THE WEST LINE OF JCOR 86-07100 WAS ESTABLISHED BETWEEN FOUND MONUMENTS PER SURVEY 10533. NOTE, THE MONUMENT FOUND AT THE NORTH WEST CORNER OF SAID DOCUMENT IS FOUND TO HAVE MEASURED 0.65' LONGER FROM THE CENTER SECTION MONUMENT (401M) THAN THE RECORD AS SHOWN ON SURVEY 10533. THAT IS BECAUSE THE MONUMENT FOUND AT THE CENTER SECTION PER SURVEY 10533 WAS IN ERROR. SURVEY 13083 EXPLAINS THE ISSUE AND RESET THE MONUMENT IN THE CORRECT POSITION WHICH WAS
- SOUTH LINE OF JCOR 86-07100 WAS ESTABLISHED BY HOLDING THE FOUND MONUMENT AT THE SOUTH WEST CORNER AND A LINE PARALLEL WITH THE NORTH LINE (PER JCOR 86-07100)
- 4. THE RIGHT OF WAY OF SPRINGBROOK ROAD WAS ESTABLISHED PER DOCUMENTS LISTED AND FOUND MONUMENTS PER SURVEY
- MAPS SHOWN ON SURVEYS 12053 AND 12278. MONUMENTS WERE SEARCHED FOR BUT NOT FOUND ALONG THE STREAM ON THE WEST AND NORTH LINE, BUT MANY MONUMENTS WERE FOUND THAT WERE SET IN THE SAME TIME FRAME BY RELATED SURVEYS ALL DONE BY HOFFBUHR & ASSOC. AND THESE FOUND MONUMENTS WERE SHOWN AND LISTED ON MONUMENT PERPETUATION SURVEY 23319 AS POINT NUMBERS 336M, 337M, 338M, 339M, 340M, 341M, 637M, 330M, 331M, 329M, 401M, 408M, AND 407M. THESE LISTED MONUMENTS REASONABLY FIT THE RECORD LOCATION PER THE SURVEYS THEY WERE SET PER, SO I HAD NO ISSUE RE-ESTABLISHING THE WEST AND NORTH LINE PER RECORD DATA. NORTH LINE FIT THE COMMON FENCE LINE, AND NO LINES OF OCCUPATION ARE NEAR THE WEST LINE.
- THE ADJUSTED PROPERTY LINE WAS ESTABLISHED AS DIRECTED BY THE CITY ENGINEERING DEPARTMENT AND WAS APPROVED BY THE CITY PLANNING DEPARTMENT.


