LOCATION:

Located within the Southeast One-quarter of Section 16, Township 34 South, Range 1 West of the Willamette Meridian, in the city of Shady Cove, Jackson County, Oregon.

PURPOSE OF SURVEY:

Pursuant to Client's request and direction, perform a boundary survey to recover existing monuments of record, perform a boundary resolution, establish monuments as necessary and file a Map of Survey in the office of the Jackson County Surveyor.

SURVEY REFERENCES/PROCEDURES:

Equipment/Software utilized: Trimble TSC7 data collector with Trimble Access Software; Trimble R10 GNSS equipment; Trimble SX10 robotic and scanning instrument; Trimble Business Center and Trimble Terramodel.

Records utilized: Instrument Numbers 2018-036776 and 2018-036983 of the Official Records of Jackson County, Oregon; HILLSIDE ADDITION TO EDGEWOOD PARK, recorded April 4, 1923, in Volume 5 of Plats Page 14 of the Records of Jackson County, Oregon; and, Surveys Numbered 3633, 17373, 18825, and 22855, all as filed in the office of the Jackson County Surveyor.

Linear unit (horizontal) is International Foot (ift); Linear unit (vertical) is U.S. Survey Foot (usft); Vertical datum is the North American Datum of 1988 (NAVD88); Geodetic Information: Datum is the North American Datum (NAD) of 1983 (2011) Epoch 2010.00; System is the Oregon Coordinate Reference System; Zone is the Grants Pass-Ashland (Refer to ORS, Chapter 93.312(c)).

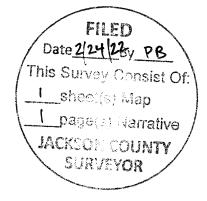
All bearings and distances shown hereon are projected (grid) values based on the projection definition herein and above. This projection was utilized in order to minimize the difference between projected (grid) distances and horizontal (ground) distances at the topographic surface within the design area of this coordinate system. The basis of bearings is Geodetic North. Note that the grid bearings depicted do not equal geodetic bearings due to meridian convergence.

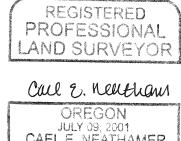
The subject tracts of land located in said Hillside Addition to Edgewood Park, are described as Lot 8 and the south half of Lot 9 in said Instrument Number 2018-036776, as well as Lot 10 and the north half of Lot 9 in said Instrument Number 2018-036983. The following procedures were utilized to resolve the subject tracts boundaries utilizing record data and located and tied monuments:

Held the Southeast Sixteenth corner of Section 16 per Survey Number 3633; Held monuments set per Surveys Numbered 17373, 18825, and 22855 to establish the westerly right-of-way of Rogue River Drive; from which, held record dimensions to establish the easterly right-of-way thereof, thereby resolving the westerly boundaries of said Instruments Numbered 2018-036776 and 2018-036983; Held said plat Hillside Addition to Edgewood Park and a found 3/4-inch diameter pipe at the easterly end of the line common to Lots 10 and 11 thereof, to compute the said common boundary and the northerly boundary per said Instrument Number 2018-036983; Held said plat, instruments and Survey Number 18825 to compute the remaining boundaries of the subject tracts.
