SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

TO SURVEY THAT TRACT OF LAND DESCRIBED WITHIN INSTRUMENT NUMBER 2017-015202, OF THE JACKSON COUNTY OFFICIAL RECORDS, OREGON.

USING A TRIMBLE S-6 ROBOTIC TOTAL STATION AND R-10 GPS RECEIVERS, I RECOVERED AND TIED EXISTING MONUMENTS OF RECORD AS SET ON SURVEY NUMBER (S/N) 4095 AND 4268. IT BECAME APPARENT THAT DUE TO THE AGE OF THE CORNERS, AND THE STEEP TERRAIN, MOST OF THE CORNERS HAVE SHIFTED NORTHERLY (DOWNHILL) AND THAT IT WOULD BE NEARLY IMPOSSIBLE TO MAKE THE FOUND CORNERS FIT THE DEED LOCATIONS. TO REMEDY THIS, I HELD THE RECORD DESCRIPTION FOR THAT TRACT OF LAND LABELED AS "TIMBERLAKE DRIVE" ON SAID S/N 4095. I THEN HELD THE RECORD DISTANCE EASTERLY FROM THE SOUTHWEST 1/16 CORNER TO PLACE THE SOUTHWESTERLY CORNER OF SAID TRACT. THIS RESULTS IN THE DISTANCES FROM THE OTHER EXTERIOR CORNERS OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 25 TO FET VERY WELL WITH THE RECORD DISTANCES TO THE TERMINUS CORNERS OF SAID TRACT. THE TWO CORNERS RECOVERED AT THE NORTHWEST CORNER OF THE SUBJECT PROPERTY WERE FOUND TO BE ±5' FROM THE RECORD POSITIONS. TO MAINTAIN THE CONTINUITY OF S/N 4095, THE CENTERWEST 1/16 AND CENTER 1/4 CORNER POSITIONS WERE HELD AND REFERENCED AS SHOWN ON SAID S/N.
