

NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO RESOLVE AND MONUMENT THE EXTERIOR BOUNDARY OF THOSE TRACTS OF LAND DESCRIBED IN DEEDS TO MEDFORD URBAN RENEWAL AGENCY RECORDED AS DOCUMENT NUMBERS 2019-029388, 2019-032583 AND 2019-040224, JACKSON COUNTY DEED RECORDS.

THE NORTHEASTERLY LINE OF SAID DOCUMENT NUMBERS 2019-029388, 2019-032583 AND 2019-040224 WAS ESTABLISHED AS THE SOUTHWESTERLY RIGHT-OF-WAY LINE OF CENTRAL AVENUE, HELD MONUMENT 'A' (PER R5) AND MONUMENT 'B' (PER R6).

THE NORTHWESTERLY LINE OF SAID DOCUMENT NUMBERS 2019-032583 AND 2019-040224 WAS ESTABLISHED THROUGH MONUMENT 'A' (PER R5) AND THROUGH MONUMENT 'C' (PER R8).

THE SOUTHWESTERLY LINE OF SAID DOCUMENT NUMBERS 2019-029388 AND 2019-040224 WAS ESTABLISHED AS THE NORTHEASTERLY RIGHT-OF-WAY LINE OF THE SOUTHERN PACIFIC RAILROAD, HELD LINE THROUGH MONUMENTS 'D' (PER R4), 'E' (PER R4) AND 'F' (PER R7).

THE NORTHWESTERLY LINE OF SAID DOCUMENT NUMBER 2019-029388 WAS ESTABLISHED THROUGH MONUMENTS 'E' AND 'G' (PER R3 & R4). THE SOUTHEASTERLY LINE OF SAID DOCUMENT NUMBER 2019-029388 WAS ESTABLISHED AT RECORD DISTANCES FROM THE NORTHWESTERLY LINE, DEFINED ABOVE, ALONG THE NORTHEASTERLY RIGHT-OF-WAY LINE OF SOUTHERN PACIFIC RAILROAD AND THE SOUTHWESTERLY RIGHT-OF-WAY LINE OF CENTRAL AVENUE (PER R7 & R10).

THE BASIS OF BEARINGS FOR THIS SURVEY IS OREGON COORDINATE REFERENCE SYSTEM (OCRS) GRANTS PASS-ASHLAND ZONE. THE RESULTANT BEARING OF THE SOUTHWESTERLY RIGHT-OF-WAY OF CENTRAL AVENUE FROM MONUMENT 'A' TO MONUMENT 'B' IS SOUTH 35°25'56" EAST 843.56 FEET.




