SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250 OREGON REVISED STATUTES

PURPOSE: To survey and monument 2 tracts as described in Instrument No. 2019—031507 of the Official Records of Jackson County, Oregon.

PROCEDURE: The westerly lines of the 2 tax lots being surveyed have been previously surveyed per file survey No. 532 and by Declans Subdivision. Monuments per those surveys were located and held to control the location of the west line. The monument as found at the southeast corner of Declans subdivision was held for the southwest corner of tax lot 1801. The northwest corner was computed at deed record distance along the Declans subdivision boundary. The southwest corner of tax lot 1900 was previously set per survey No. 532. We could find no evidence of the monument, so record distance per survey No. 532 was held from the monument, as found, from the northeast corner of the survey No. 532, to reset the missing monument. The easterly lines of tax lot 1900 and 1600 were held at deed record distance from the east line of Declans Subdivision and parallel to the subdivision boundary.
