SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250, OREGON REVISED STATUTES

PURPOSE: Pursuant to Client's request and direction, perform a boundary survey, recover existing monuments of record, perform a boundary resolution, establish monuments as necessary and file a Map of Survey in the office of the Jackson County Surveyor.

PROCEDURE: Equipment/Software utilized: Trimble TSC7 data collectors with Trimble Access Software; Trimble RIO GNSS equipment; Trimble SXIO robotic and scanning Instrument; Trimble Business Center and Trimble Terramodel. Records utilized: Volume 474 at Page 290, Volume 504 at Page 253 and Volume 511 at Pages 222-266, all of the Deed Records of Jackson County, Oregon; Instruments Numbered 2006-015971 and 2022-008424 of the Official Records of Jackson County, Oregon; CRATER PARK SUBDIVISION, recorded July 17, 1957, in Volume 8 of Plats Page 2 of the Records of Jackson County, Oregon; Oregon State Highway Department (now known as Oregon Department of Transportation) Drawing Number 7B-22-09; and Survey's Numbered 2173, 20913 and 23159, all as filed in the office of the Jackson County Surveyor.

Linear unit (horizontal) is international Foot (ift); Linear unit (vertical) is U.S. Survey Foot (usft); Vertical datum is the North American Datum of 1988 (NA VD88); Geodetic Information: Datum is the North American Datum (NAO) of 1983 (2011) Epoch 2010.00; System is the Oregon Coordinate Reference System; Zone is the Grants Pass-Ashland (Refer to ORS, Chapter 93.312(c)).

All bearings and distances shown hereon are projected (grid) values based on the projection definition herein and above. This projection was utilized in order to minimize the difference between projected (grid) distances and horizontal (ground) distances at the topographic surface within the design area of this coordinate system. The basis of bearings is Geodetic North. Note that the grid bearings depicted do not equal geodetic bearings due to

Resolved subject tract boundaries, as described as Parcel II per said Instrument Number 2022-008424 as follows: Held found monuments at the northwest corner of Donation Land Claim (DLC) Number 59 (also being the northeast corner of DLC 60), and the southeast corner of DLC 60 (also being the northeast corner of DLC 61) to establish the westerly boundary of DLC 59; Utilized said DLC line, Survey Number 23159 and said Volume 474 at Page 290 to locate the centerline of Oregon Route 99 (commonly known as Hwy 99), thereby resolving the westerly boundary said Crater Park Subdivision, thereby resolving the westerly boundary of the subject tract; Utilized found monuments, said Instrument Number 2016-015971 and Surveys Numbered 20913 and 23159 to resolve the northerly boundary of the subject tract; Utilized found monuments and said Crater Park Subdivision to resolve the easterly boundary of the subject tract; Utilized found monuments and said Crater Park Subdivision to resolve the Pages 253 and Volume 511 at Pages boundary of the subject tract; Utilized found monuments, said Volume 504 at Page 253 and Volume 511 at Pages 222-226, and Survey Number 2173 to resolve the southerly boundary of the subject tract.

Utilizing said boundary resolution and based on information by client, established location of the proposed lease area boundary and thence completed establishing monuments, as depicted on the map, on June 28, 2022.
