SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250 OREGON REVISED STATUTES

PURPOSE: To survey and monument a property line adjustment/lot consolidation of 3 properties described in Instrument No. 2017-003619, (tax lot 6200), Instrument No. 2019-00007 (tax lot 6100) and Instrument No. 92-11440 (tax lot 6000) of the Official Records of Jackson County, Oregon, and as approved by the Jackson County Development Services (File No. 439-22-00043-SUB). The west half of Tax Lot 6100 is being consolidated with Tax Lot 6200 and the east half of tax lot 6100 is being consolidated with tax lot 6000.

PROCEDURE: The 3 properties affected by this adjustment/consolidation are located within Lot 12 of Block 2 of Clymer Heights Subdivision. Existing monuments, as found, per Clymer Heights Subdivision and Survey No. 21629 were held for the boundary of Lot 12. The boundary of Tax Lot 6200 was previously monumented per survey No. 21629. The southwest corner of the tax lot 6200 has been destroyed and I reset it at record location per the survey No. 21629. The tax lot 6200 south line was held for the location of the new adjusted south line and the location of the new north—south boundary common to tax lot 6200 and tax lot 6000 was computed according to client's instruction and monuments were set as shown.
