SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250, OREGON REVISED STATUTES

PURPOSE: Pursuant to Client's request and direction, perform a boundary survey to recover existing monuments of record, perform a boundary resolution to determine the exterior boundaries of the subject tract, establish monuments as necessary and to file a Map of Survey in the office of the Jackson County Surveyor.

PROCEDURE: Equipment/Software utilized: Trimble TSC7 data collector with Trimble Access Software; Trimble RIO GNSS equipment; Trimble S7 robotic instrument; Trimble SXIO robotic and scanning instrument; Trimble Business Center and Trimble Terramodel. Records utilized: Instrument Number 2019-012526 of the Official Records of Jackson County, Oregon; HIGH OAKS SUBDIVISION, recorded April 4, 1973, in Volume 12 of Plats at Page I of the Records of Jackson County, Oregon; and, Survey's Numbered 10439, 14776 and 20600, as filed in the office of the Jackson County Surveyor.

Linear unit (horizontal) is International Foot (ift); Linear unit (vertical) is U.S. Survey Foot (usft); Vertical datum is the North American Datum of 1988 (NAVD88); Geodetic Information: Datum is the North American Datum (NAD) of 1983 (2011) Epoch 2010.00; System is the Oregon Coordinate Reference System; Zone is the Grants Pass-Ashland (Refer to ORS, Chapter 93.312(c)).

All bearings and distances shown hereon are projected (grid) values based on the projection definition herein and above. This projection was utilized in order to minimize the difference between projected (grid) distances and horizontal (ground) distances at the topographic surface within the design area of this coordinate system. The basis of bearings is Geodetic North. Note that the grid bearings depicted do not equal geodetic bearings due to meridian convergence.

Subject property is described in said Instrument Number 2019-012526, being a portion of Lot 10 of said High Oaks Subdivision (hereafter referred to as "plat"). The following procedures performed to resolve the exterior boundaries of the subject property: Searched for all monuments along Mariposa Terrace at Lots 5 through II of said plat, resulting in not finding many monuments and most did not fit together versus plat record. Held the found monument per said plat at the northwest corner of, and in conjunction with found monuments per Surveys Numbered 10439, 14776 and 20600 to resolve the location of the northerly boundary of said subject property. From which, held a found monument called for in the said Instrument Number 2019-012526 (no survey of record found for said monument) and record turning angles to resolve the location of the remaining boundaries of the subject property.

Monuments, as depicted hereon, were established on January 13, 2023.
