KNOW ALL MEN BY THESE PRESENTS, that I, Darrell L. Huck, a duly Registered Professional Land Surveyor in the State of Oregon, do hereby affirm that I have established, with proper monuments as required by law, those monuments as shown as deferred on the Official Plat of <u>TABLE</u> <u>ROCK CROSSING SUBDIVISION</u>, recorded April 5, 2021 in Volume 47 of Plats at Page 05 of Records in Jackson County, Oregon.

In addition, 6 inch Mag spikes with metal washers marked "L.S. 2023" were set at the south-west corner of Lot 3 and at the Northwest corner and the Southeast corners of Lot 5, and at the Northwest corner of Lot 6.
