<u>PURPOSE</u>: To survey and monument the corners of two Parcels created through a Land Partition of that property set forth in Doc. 2021-052418, ORJCO and approved under City of Talent File MLP-2023-003.

PROCEDURE: Many of the controlling monuments were initially tied by this office after the 2020 Almeda Fire and are shown on Survey No. 23268 and 23771. Using Trimble R10 Receivers made ties to monuments shown on Sheet 2. The direction of the NW'ly line was positioned using the found monument per FS11315 and a point 5.00' SE'ly from the witness monument per OBV. The most N'ly & W'ly corners of the subject tract were positioned at plat record distances per FS14773 from the found monument per FS11315. With the exterior boundary resolved, computed the position of the interior Parcel corners and set monuments as shown on Sheet 2. Due to improvements constructed after the 2020 Almeda fire, witness corner monuments were set as shown.
