


SURVEY TO PARTIALLY SUBDIVIDE SECTION 12,



Survey to Partially Subdivide Section 12, T36S, R4W, W. M., Jackson County, Oregon., Pursuant to Survey of "HIGHLAND MEADOWS."

Survey Narrative to Comply with Par. 209-250, O.R.S.

For: Donald M. Straus, Kay L. Straus, Frank M. Straus, P.O. Box 307, Gold Hill, Oregon, and Don C. Skillman and Lillian A. Skillman, P.O. Box 299, Rogue River, Oregon.

Purpose: To locate the necessary legal boundaries and corners for the above owners in order to survey "HIGHLAND MEADOWS."

Procedure: Corner information data, relating to corners found and set, is listed hereafter in this narrative. Bearings are based on solar observations taken during the course of the survey. After tying in to all original government corners (shown on the attached map) by closed traverse, I compute the true bearings and survey those lines required, using the South Quarter Corner as the initial point of the subdivision.

The original Ward's Creek Road cannot be located exactly from the records (40 foot width) so the travelled portion of the roadbed was included within the new right-of-way as shown on the subdivision plat. The beginning point and center line of the Boyd Road (per C. Z. Boyden survey and resolution of the Jackson County Court dated November 25, 1931) was located from scribing found in bearing trees marked "R" by Boyden at his survey point numbers "20" and "17" (beginning, and 3rd point of his traverse). Because of the Boyd Road bridge over Ward's Creek being built too far northerly of the road's legal centerline, it was necessary to make the new northerly right-of-way line 47 feet from the center line, in order to include the bridge in the right-of-way.

Inaccessible lot corners in Ward's Creek are witnessed by iron pipes set, as close to the creek center line as practical, on the lot lines which terminate at the creek center line. The plat shows distances from these pipes to the center of said creek, which creek forms part of the subdivision boundary except in Lots 1 and 2 of Block "3".
