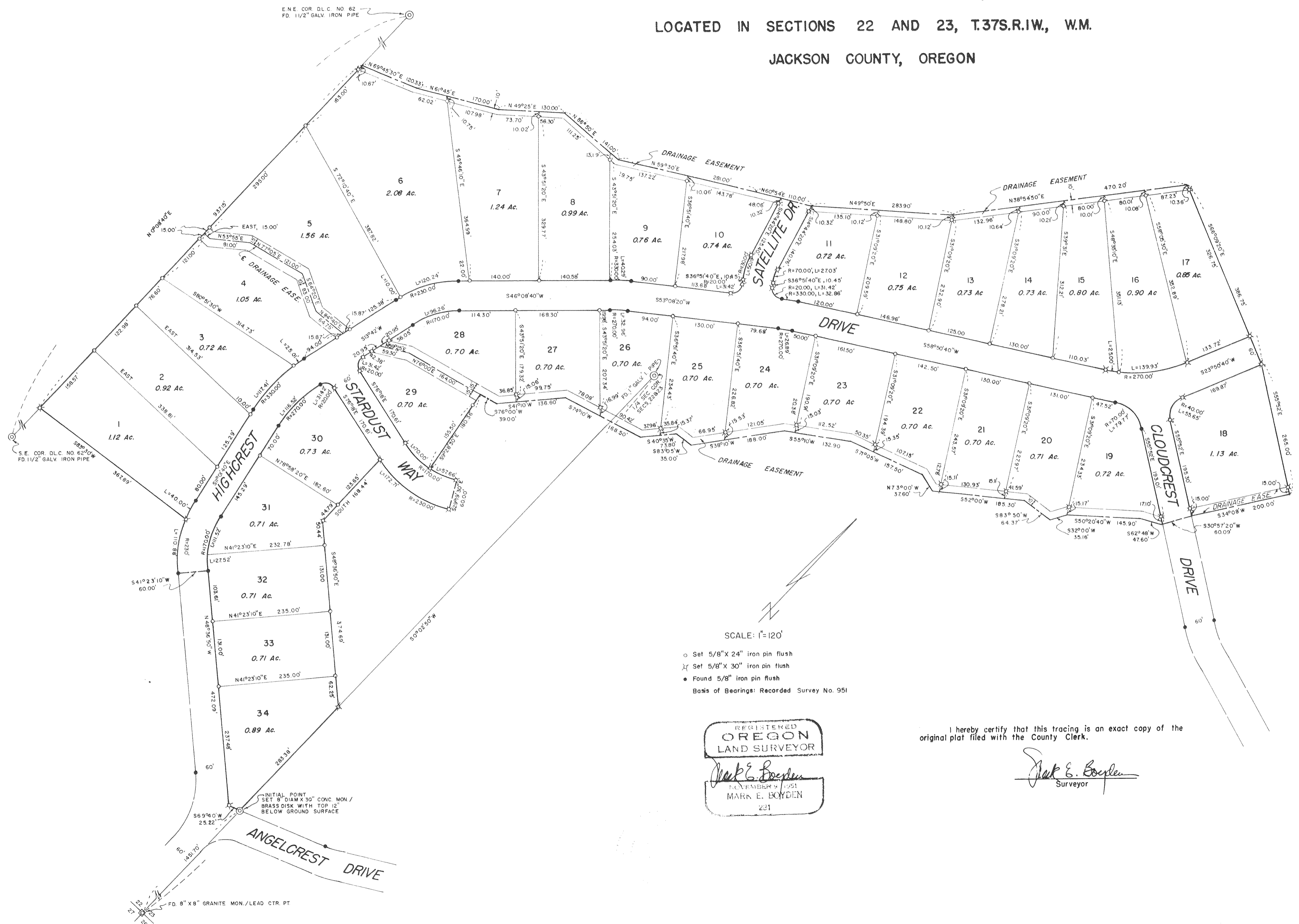


SKY CREST ESTATES SUBDIVISION, UNIT No. 1

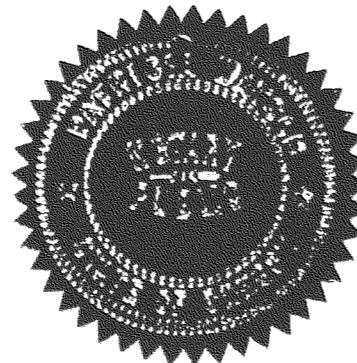

SURVEYOR'S CERTIFICATE

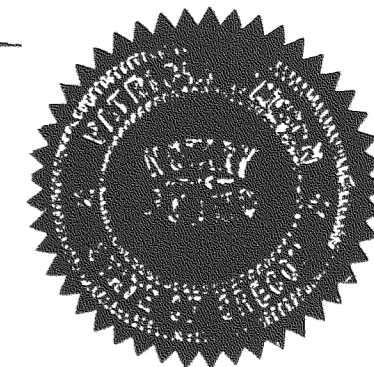

I, Mark E. Boyden a duly registered surveyor of the State of Oregon, being first duly sworn, do hereby certify that I have correctly surveyed and marked with the proper monuments as provided by law the tract of land hereon shown and the said plat is a correct representation of the same, and the following is an accurate description of the boundary lines:

Beginning at a concrete monument with brass disk located on the Northwesterly boundary of Angelcrest Drive, from which the corner common to Sections 22, 23, 26 and 27 of Township 37 South, Range 1 West of the Willamette Meridian in Jackson County, Oregon, bears South 0°02'50" West along the East boundary of said Section 22, a distance of 1451.70 feet; thence along said drive boundary, South 69°40' West, 25.22 feet; thence along the Northeasterly boundary of Highcrest Drive, North 48°36'50" West, 472.09 feet; thence South 41°23'10" West, 60.00 feet; thence along the Southwesterly boundary of Highcrest Drive 110.88 feet along the arc of a curve right (which arc has a radius of 230.00 feet and a long chord of North 34°48'10" West, 109.81 feet); thence leaving said drive boundary, South 83°30' West, 367.89 feet to intersect the East boundary of Donation Land Claim No. 62 of said township and range; thence along the East boundary of said claim, North 0°08'40" East, 937.15 feet; thence North 69°45'30" East, 120.33 feet; thence North 6°45' East, 170.00 feet; thence North 49°25' East, 130.00 feet; thence North 86°50' East, 141.00 feet; thence North 59°30' East, 281.00 feet; thence North 60°54' East, 110.00 feet; thence North 49°50' East, 283.90 feet; thence North 38°54'50" East, 470.20 feet; thence South 66°09'20" East, 386.75 feet; thence South 55°52' East, 265.00 feet; thence South 34°08' West, 200.00 feet; thence South 30°57'20" West, 60.09 feet; thence South 62°48' West, 47.60 feet; thence South 50°20'40" West, 145.90 feet; thence South 32°00' West, 35.16 feet; thence South 83°50' West, 64.37 feet; thence South 52°00' West, 185.30 feet; thence North 73°00' West, 37.60 feet; thence South 71°05' West, 157.50 feet; thence South 55°10' West, 132.90 feet; thence South 38°10' West, 188.00 feet; thence South 83°05' West, 35.00 feet; thence South 40°35' West, 73.80 feet; thence South 74°10' West, 168.50 feet; thence South 41°10' West, 136.60 feet; thence South 76°00' West, 39.00 feet; thence South 9°28'30" East, 180.36 feet; thence 57.66 feet along the arc of a curve left (which arc has a radius of 170.00 feet and a long chord of North 70°23'30" East, 57.38 feet); thence South 29°19'30" East, 60.00 feet; thence 172.71 feet along the arc of a curve right (which arc has a radius of 230.00 feet and a long chord of South 82°11'5" West, 168.68 feet); thence South 168.44 feet; thence South 48°36'50" East, 374.69 feet; thence South 0°02'50" West, 283.38 feet to the point of beginning.

EXCEPTING THEREFROM that portion of the hereinabove described tract that lies within the right-of-way of Highcrest and Cloudcrest Drives, as the same were conveyed to Jackson County and recorded in Volume 596, Pages 471-476 of the Deed Records of Jackson County, Oregon.
