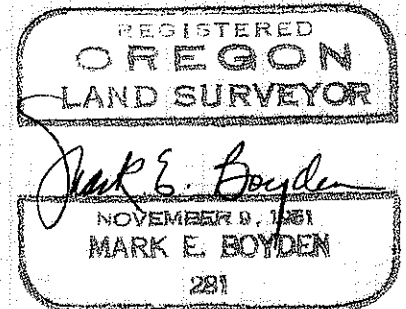

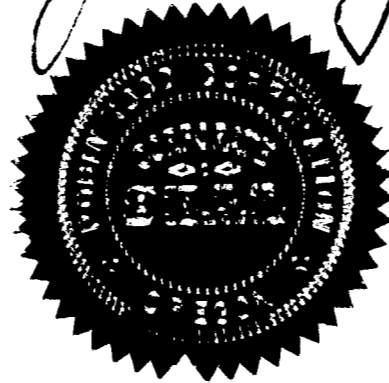
DEDICATION

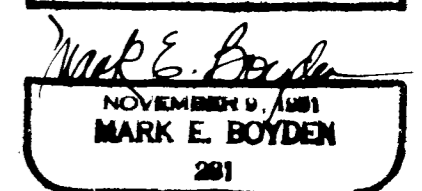
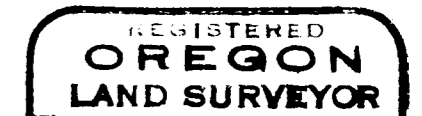

I, Mark E. Boyden a duly registered surveyor of the State of Oregon, being first duly sworn, do hereby certify that I have correctly surveyed and marked with the proper monuments as provided by law the tract of land hereon shown and the said plat is a correct representation of the same, and the following is an accurate description of the boundary lines:

Beginning at a concrete monument with brass disk located on the Northwesterly boundary of Angelcrest Drive, from which the corner common to Sections 22, 23, 26 and 27 of Township 37 South, Range 1 West of the Willamette Meridian in Jackson County, Oregon bears South 0°02'50" West along the East boundary of said Section 22, a distance of 1451.70 feet; thence along the boundaries of SKY CREST ESTATES SUBDIVISION, UNIT NO. 1 (Recorded) as follows: North 0°02'50" East, 283.38 feet; thence North 48°36'50" West, 374.69 feet; thence North, 168.44 feet, thence 172.71 feet along the arc of a curve left (which arc has a radius of 230.00 feet and a long chord of North 82°11'15" East, 168.68 feet); thence North 29°19'30" West, 60.00 feet; thence 57.66 feet along the arc of a curve right (which arc has a radius of 170.00 feet and a long chord of South 70°23'30" West, 57.38 feet); thence North 9°28'30" West, 180.36 feet; thence North 76°00' East, 39.00 feet; thence North 41°10' East, 136.60 feet; thence North 74°10' East, 168.50 feet; thence North 40°35' East, 73.80 feet; thence North 83°05' East, 35.00 feet; thence North 38°10' East, 188.00 feet; thence North 55°10' East, 132.90 feet; thence North 71°05' East, 157.50 feet; thence South 73°00' East, 37.60 feet; thence North 52°00' East, 185.30 feet; thence North 83°50' East, 64.37 feet; thence North 32°00' East, 35.16 feet; thence North 50°20'40" East, 145.90 feet; thence North 62°48' East, 47.60 feet; thence North 30°57'20" East, 60.09 feet; thence North 34°08' East, 200.00 feet; thence leaving said SKY CREST ESTATES SUBDIVISION, UNIT NO. 1 boundary, North 34°08' East, 75.00 feet; thence South 55°52' East, 356.33 feet; thence South 76°57' East, 279.70 feet; thence South 55°24' East, 249.42 feet; thence South 34°36' West, 260.00 feet; thence South 55°24' East, 68.81 feet; thence South 32°54' West, 1168.77 feet; thence South 60°44'20" West, 321.35 feet; thence North 29°15'40" West, 260.00 feet to the Northwesterly boundary of Angelcrest Drive; thence along said drive boundary, South 60°44'20" West, 631.65 feet; thence along said drive boundary 42.07 feet along the arc of a curve right (which arc has a radius of 270.00 feet and a long chord of South 65°12'10" West, 42.03 feet); thence along said drive boundary, South 69°40' West, 186.41 feet to the point of beginning.

EXCEPTING THEREFROM that portion of the hereinabove described tract that lies within the right-of-way of Cloudcrest and Angelcrest Drives, as the same were conveyed to Jackson County and recorded in Volume 596, Pages 470-476 of the Deed Records of Jackson County, Oregon.

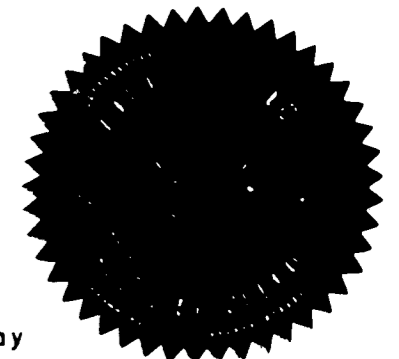

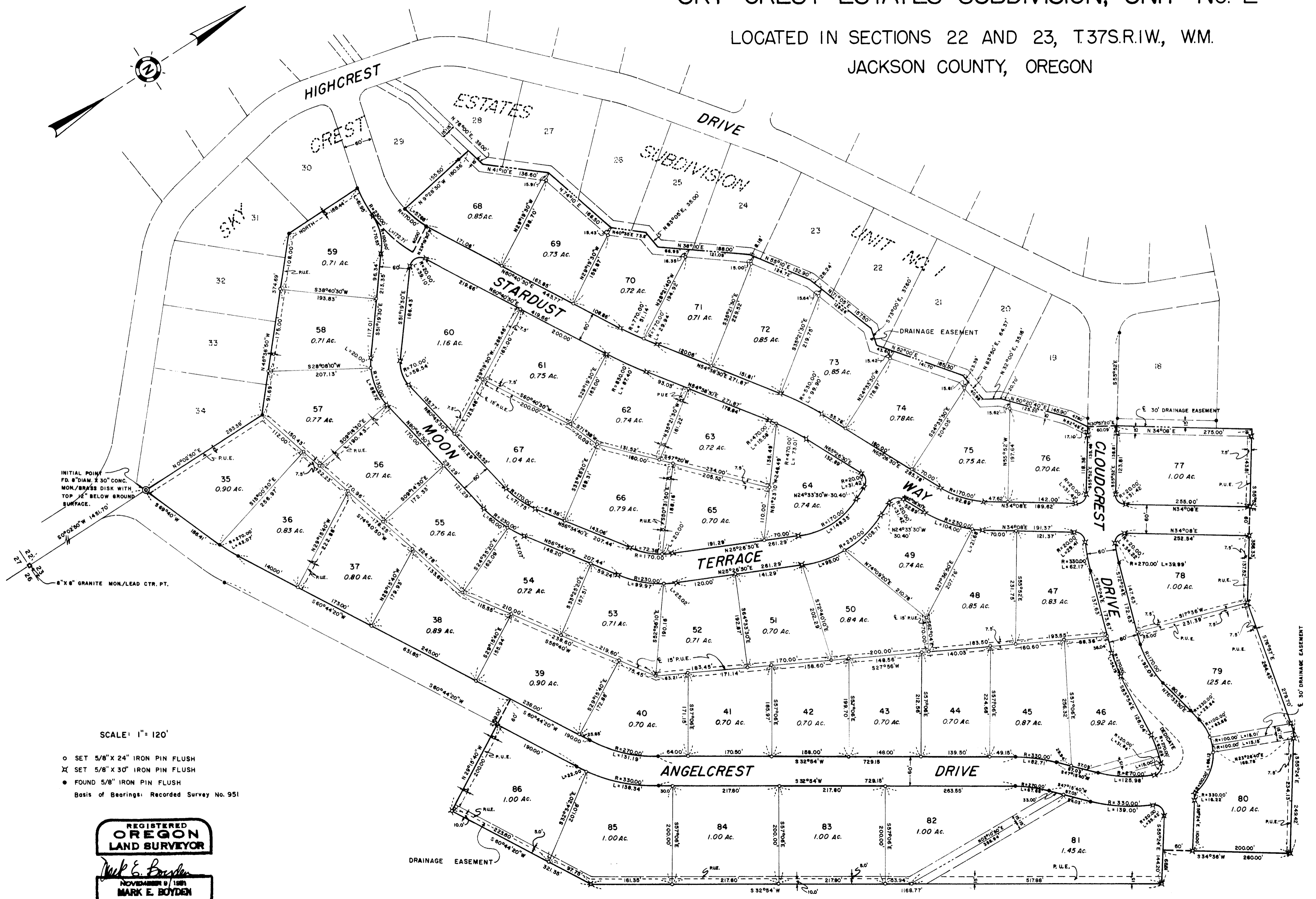
