

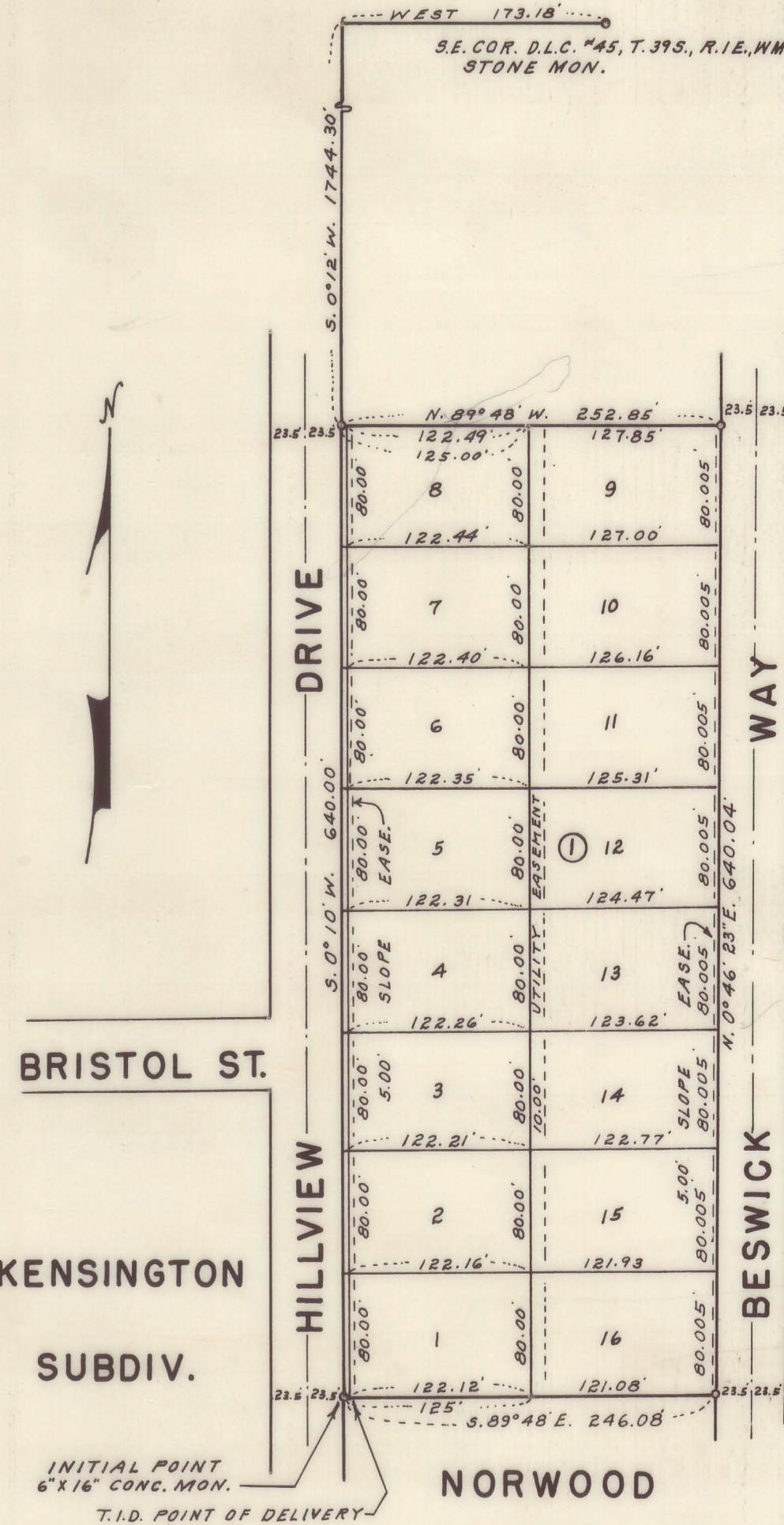

## SURVEYOR'S CERTIFICATE

I, L.E. Ager, a duly registered Surveyor of the State of Oregon, being first duly sworn, do hereby certify that I have correctly surveyed and marked with the proper monuments as provided by law, the tract of land hereon shown and the said plat is a correct representation of the same, and the following is an accurate description of the boundary lines: Beginning at a six inch by sixteen inch concrete monument with metal disc set six inches below the ground surface on the South line of Lot 35, Bellevue Tracts in the City of Ashland, Jackson County, Oregon, according to the official plat thereof, now of record, which monument bears S. 89° 48' E. 20.62 feet from the Southwest corner of said Lot 35 and 23.50 feet East of the center line of Hillview Drive; thence South 89° 48' E., along the South line of said Lot, 246.08 feet to the West line of Beswick Way; thence N. 0° 46' 23" E. along said line, 640.04 feet; thence N. 89° 48' W. 252.85 feet to a point 23.50 feet East of the center line of Hillview Drive; thence S. 0° 10' W., parallel with said center line, 640.00 feet to the point of beginning; Excepting therefrom that portion along the West line thereof conveyed to the City of Ashland.

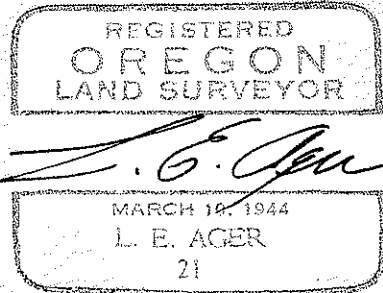
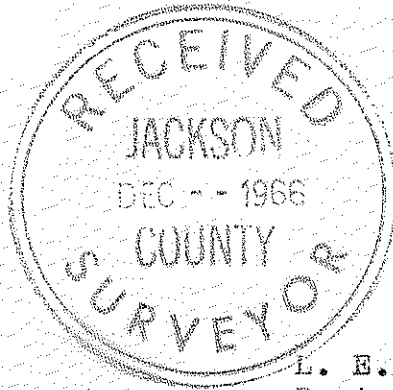
