


## SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250, REVISED BY CHAPTER 555, O.L. 1963

PURPOSE: To monument the boundaries of Lots 13, 14 and 15 of Block 1 of the

FOR: Shell Oil Company 837 East Main Street Medford, Oregon

by the City Engineer.

LEWIS ADDITION to the City of Medford, Jackson County, Oregon

PROCEDURE: Between the years 1946 to 1950, the City of Medford in cooperation

with Jackson County, conducted an extensive survey in the West part of Medford

to determine what controls should be used to establish street locations and

property boundaries in this part of the city. Although West Main Street had

once been monumented by the City Engineer, construction and maintenance of the

street-car line which ran down the center of said street had either destroyed

or moved most of these monuments. After consolidating all the survey in
formation gained from references and old survey records, it was determined that

the centerline control should run between the established monument at Oakdale

Avenue and an old centerline pin at Columbus Avenue and that intermediate

The centerline control for West Fourth Street was established between the angle point in said street and the center at Columbus Avenue which also checked the old center at Rose Avenue.

intersections should fall on this line and would be controlled East and West by

old references, ties, street improvements or other survey controls as approved

In 1950, new monuments were set by the City for many of the street centers West of Oakdale Avenue including the intersection of North Orange with West Main and West Fourth Street. At this time it was determined that the centerline of North Peach should run from the monument at Fourth Street to a point 0.11 feet East of the monument at West Main which monument is also South of the true centerline of West Main Street. This centerline of North Peach Street was utilized for control on Recorded Survey No. 212.

Using the above controls, it was determined that the distance from West Main Street to Fourth Street is so near record that the depth of Lots 13, 14 and 15 would be record to the nearest hundredth of a foot. Since Lots 13 and 14, Block 2 of BUNGALOW ADDITION have been recently surveyed (see Recorded Survey No. 3287), Shell Oil Company elected not to extend beyond the monumented West Line of said Survey No. 3287, even though the property line may do so.
