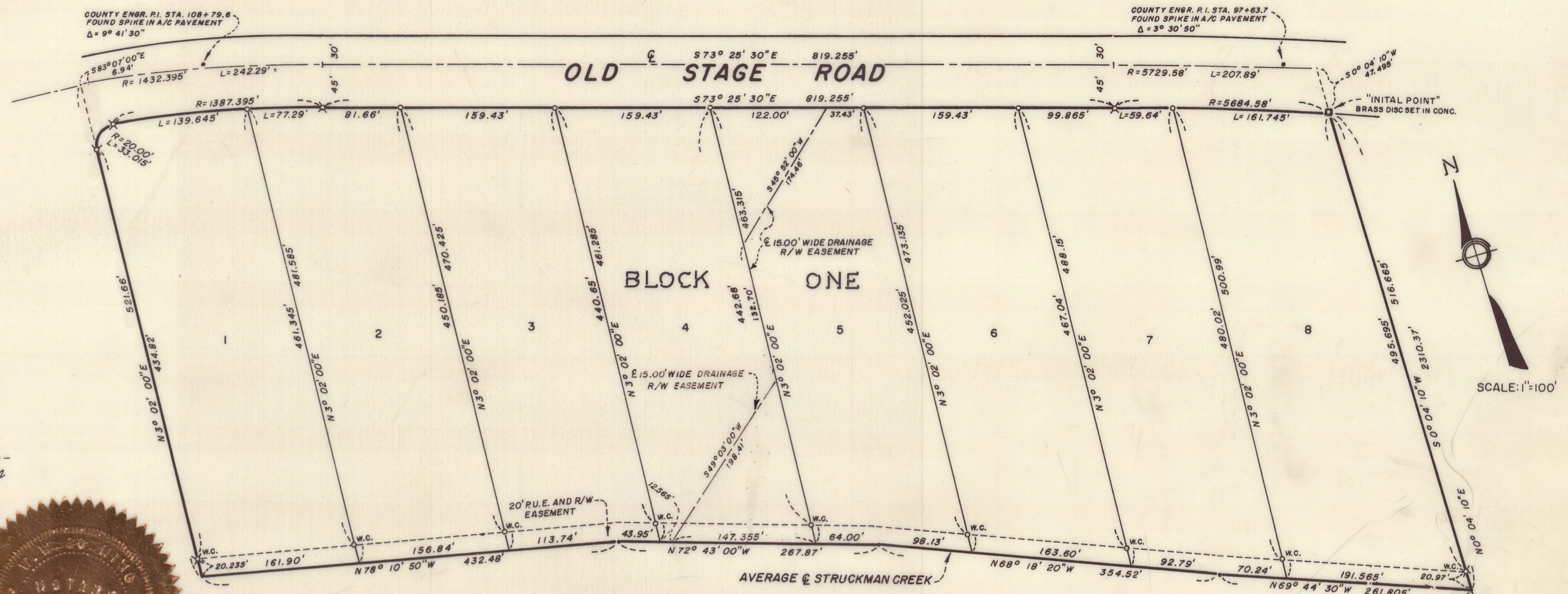

I, J. A. Hoffbuhr a duly registered Surveyor of the State of Oregon, being first duly sworn do hereby certify that I have correctly surveyed and marked with the proper monuments as provided by law the tract of land hereon shown and the said plat is a correct representation of the same, and the following is an accurate description of the boundary lines:-

COMMENCING AT THE SOUTH ONE QUARTER (1/4) CORNER OF SECTION 36, TOWNSHIP 36 SOUTH, RANGE 3 WEST OF THE WILLAMETTE MERIDIAN, JACKSON COUNTY, OREGON; THENCE ALONG THE NORTH-SOUTH CENTER LINE OF SAID SECTION 36, NORTH 0° 04' 10" EAST 2310.37 FEET TO INTERSECT THE SOUTHERLY RIGHT OF WAY LINE OF OLD STAGE (COUNTY) ROAD AND BEING THE INITIAL POINT; THENCE ALONG AFOREMENTIONED NORTH-SOUTH CENTER LINE OF SECTION 36, SOUTH 0° 04' 10" WEST 495.695 FEET TO A 5/8 INCH IRON PIN, WITNESS CORNER; THENCE CONTINUE SOUTH 0° 04' 10" WEST 20.97 FEET; THENCE ALONG THE AVERAGE CENTER LINE OF STRUCKMAN CREEK AND ITS EASTERLY PROJECTION THEREOF, NORTH 69° 44' 30" WEST 261.805 FEET, NORTH 68° 18' 20" WEST 354.52 FEET, NORTH 72° 43' 00" WEST 267.87 FEET AND NORTH 78° 10' 50" WEST 432.48 FEET; THENCE NORTH 3° 02' 00" EAST 20.235 FEET TO A 5/8 INCH IRON PIN, WITNESS CORNER; THENCE CONTINUE NORTH 3° 02' 00" EAST 521.66 FEET TO INTERSECT THE CENTER LINE OF OLD STAGE (COUNTY) ROAD; THENCE ALONG THE AFOREMENTIONED CENTER LINE AS FOLLOWS: SOUTH 83° 07' 00" EAST 6.94 FEET TO A POINT OF CURVE, AND ALONG THE ARC OF A 1432.395 FOOT RADIUS CURVE TO THE RIGHT A DISTANCE OF 242.29 FEET (THE LONG CHORD WHICH BEARS SOUTH 78° 16' 15" EAST 242.00 FEET) TO A POINT OF TANGENT, SOUTH 73° 25' 30" EAST 819.255 FEET TO A POINT OF CURVE, AND ALONG THE ARC OF A 5729.58 FOOT RADIUS CURVE TO THE RIGHT A DISTANCE OF 207.89 FEET (THE LONG CHORD WHICH BEARS SOUTH 72° 23' 10" EAST 207.89 FEET) TO INTERSECT THE NORTH-SOUTH CENTER LINE OF SECTION 36; THENCE ALONG AFOREMENTIONED NORTH-SOUTH CENTER LINE, SOUTH 0° 04' 10" WEST 47.495 FEET TO THE INITIAL POINT AND TRUE POINT OF BEGINNING.

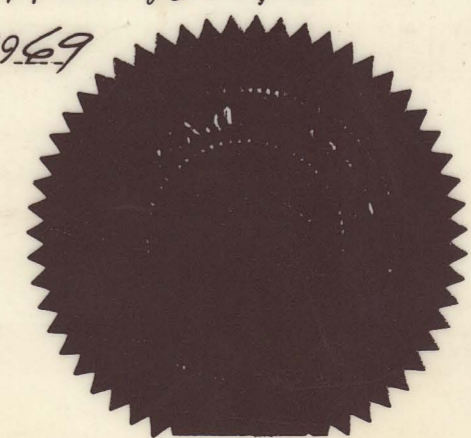

Oregon Revised Statutes

SURVEY FOR: Art E. Struckman  
Route 1, Box 303  
Central Point, Oregon

LOCATION: Tract situated in the Southwest One Quarter (1/4)  
and the Northwest One Quarter (1/4) of Section 36,  
Township 36 South, Range 3 West, Willamette  
Meridian, Jackson County, Oregon.

PURPOSE: To survey the lots as delineated on the map  
prepared for recording of the "Iron Kettle  
Subdivision".

PROCEDURE: The controls of Recorded Survey No. 3737 was used  
to establish the perimeter of the subdivision. It should be noted  
that an additional 15.00 feet of roadway was dedicated along the  
southerly line of Old Stage Road in addition to the 30.00 foot  
right of way shown on Recorded Survey No. 3737. Basis of bearings--
